– NOTICE TO EXHIBITORS –

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- The AKC will collect a \$1.50 AKC Event Service Fee and 50 cent Recording Fee for the first entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered in more than one class in the show, the Event/Recording Fees to be collected on the first entry only. (AKC Rule. Ch. 11, Sec. 2). The AKC will collect a \$3.00 per entry of dog Rally Event Service Fee. (AKC Rally Regulations, Ch. 1, Sec. 3). A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for the AKC.
- CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and/or its Superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR THE COMPLETENESS AND CORRECTNESS OF ENTRY RESTS SOLELY WITH THE ENTRANT.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund of entry fee for bitches in season. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. The Superintendent will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Superintendent will add a \$20.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.

SPECIALTY CLUB PARKING AND GROOMING

All of those Specialty Clubs that have reserved space(s) in the first row only of RV parking, will be allowed to reserve the space directly in front of their parking space(s) for grooming, or other usage. The width of the reserved area will not exceed the width of the parking space(s) and will only extend 10 feet directly in front of the parking space(s). Any usage of this area that exceeds 10 feet in front of the parking space(s) will block the fire lane and will not be allowed. Fire lanes will be strictly enforced at all times by Sammamish Kennel Club and JIFYS Parking.

DIRECTIONS TO SHOW SITE: MARYMOOR PARK

From I-5 North: Take Exit #182 to I-405 Southbound, follow it south to Exit #14-A to Hwy 520 East to Redmond and follow directions below **“From I-405.”**

From I-5 South: Take Exit #154 to I-405 Northbound, follow it north to Exit #14 to Hwy 520 East to Redmond and follow directions below **“From I-405.”**

From I-90 East: Take Exit #10 to I-405 Northbound and follow direction below **“From I-405.”**

From I-405 - Take Exit #14 for Hwy 520 East to Redmond. Go east on 520 for approx. 5 miles to the W. Lake Sammamish Parkway exit. Take the right of the 2 lanes on the exit ramp and turn right at traffic light onto W. Lk. Sammamish Pkwy. Immediately move to the left turn lane and turn left at the traffic light into Marymoor Park. Follow the main road and look for Show/Parking signs.

CANOPIES FOR SHADE ARE ALLOWED

Per AKC rules, they must be positioned 10 feet back from any ring.

A clear walkway will be maintained around the rings.

Fire Lanes will be closely patrolled, and must be kept clear.

Note: Veteran Class entrants MUST be intact. Spayed or neutered dogs/bitches are not eligible. Winners of the Veterans Classes, if otherwise undefeated at this show, are eligible to compete for Best of Breed/Variety.

BEST OF BREED (VARIETY) COMPETITION

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record. Dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owners' records. If at the end of the 90 day period the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC."

Dachshunds (Wirehaired): Open Classes Divided, Both Sexes: Miniature (under 11 lbs. & 12 mos. old or over); Standard (11 lbs. & over and under 11 lbs. if less than 12 mos. old).

Boxers: Open Classes Divided, Both Sexes: Brindle; Fawn.

Bullmastiffs: Open Classes Divided, Both Sexes: Brindle; Any Other Allowed Color.

Doberman Pinschers: Open Classes Divided, Both Sexes: Black; Any Other Allowed Color.
