NOVICE CLASS: For Boys and Girls who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show. NOVICE CLASS DIVIDED: Junior-9 years and under 12 years old on the day of the show; Intermediate -12 years and under 15 years old on the day of the show. Senior-15 years and under 18 years old on the day of the show.

OPEN CLASS: For Boys and Girls who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show. OPEN CLASS DIVIDED: Junior-9 years and under 12 years old on the day of the show; Intermediate -12 years and under 15 years old on the day of the show. Senior-15 years and under 18 years old on the day of the show

NOTICE TO EXHIBITORS REGARDING CORRECTIONS OR CHANGES TO ENTRIES: Corrections other than the specific changes listed in AKC Rules, Ch. 11, Sec. 6 (i.e. sex of a dog, transfers between age specific classes, and "move-up's" to BOB or BOV) are the only changes to the entries superintendents or secretaries are authorized to make after closing of entries. The Bred-by-Exhibitor Class shall be for dogs that are: Individually registered with the American Kennel Club as of the date of closing of entries for the show and owned or co-owned by any of the breeders of record as of the date of the closing of entries for the show. The person handling the dog in this class must be a breeder of record and an owner of record of this dog.

HERDING TITLE DOG CLASS HERDING TITLE BITCH CLASS

A Class for Dogs/Bitches that have achieved an AKC Herding Trial title (HS, HI, HX, HCH). Winners of the above non-regular classes, if otherwise undefeated, will compete for Best of Breed.

BEST OF BREED COMPETITION

AWARD OF MERIT: At the end of the Best of Breed competition, the judge will choose some other dogs or bitches in that competition that she feels are of equal merit to the Best of Breed winner. The maximum number of Award of Merit prizes will be one per ten Briards showing up for the Best of Breed Competition with a maximum of 10 prizes. BOB and BOS do not receive Awards of Merit.

BEST PUPPY FROM THE REGULAR PUPPY CLASSES: Winners in the Regular Puppy Classes (6-9 mos. & 9-12 mos.) will compete for this Special Award.

BEST VETERAN FROM THE VETERANS CLASSES: Winners of all the Veteran Classes will compete for this Special Award.

BEST FROM THE BRED-BY-EXHIBITOR CLASSES: Winners of the Bred-By-Exhibitor Classes will compete for this Special Award.

Non-Regular Classes (Involving multiple Dog Entries)

STUD DOG CLASS: For Stud Dogs and two of their Get. Stud dog must be entered in the Stud Dog Class and shown in the ring with their Get. Owner of the Stud Dog need not necessarily be the owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in a regular class. Best of Breed. or some other non-regular class.

BROOD BITCH CLASS: For Brood Bitches and two of their Produce. Brood Bitch must be entered in the Brood Bitch Class and shown in the ring with their Produce. Owner of the Brood Bitch need not necessarily be the owner of the Produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Produce must be entered in a regular class. Best of Breed. or some other non-regular class.

BRACE CLASS: For two dogs that are similar in appearance, performing in unison and presented by a maximum of two handlers. Both dogs competing in brace competitions *must have a least one common owner*. Dogs need not be entered in another class. Brace Class must be indicated on the entry form. If more than one Brace is entered by common owners, the dogs comprising each Brace Unit must be designated "Brace #1, Brace #2," etc.

NOTE: As the judge's decision in the Stud Dog, Brood Bitch and Brace Classes is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.

SWEEPSTAKES

A Sweepstakes will be held in conjunction with this Specialty. Sweepstakes will be judged Friday, September 30, 2005. All dogs and bitches entered in Sweepstakes MUST ALSO be entered in a Regular Class at this Specialty, at the regular entry fee. The Sweepstakes is open to all Briard dogs/bitches who are at least 6 months of age and under 18 months of age on the day of the Sweepstakes. Entries must be made at the same time and on the same entry form as the regular classes, indicating in the space for "Additional Classes" your entry in Sweepstakes. Owner or breeder or member of their family must handle entries. Should the owner or breeder be unable to handle or have more than one dog in the same class, any non-professional handler will be acceptable. A professional handler shall be defined as any person, with the exception of members in good standing of the BCA, who has received a fee for handling a dog in competition during the previous 12 months.

Owner or breeder or member of their family must handle entries. Should the owner or breeder be unable to handle or have more than one dog in the same class, any non-professional handler will be acceptable. A professional handler shall be defined as any person, with the exception of members in good standing of the BCA, who has received a fee for handling a dog in competition during the previous 12 months.

 in any Rally class rests solely with the person entering the dog. ALSO, Advanced and Excellent entries
 MUST include jump height.
