

HERDING TITLE DOG CLASS HERDING TITLE BITCH CLASS

A Class for Dogs/Bitches that have achieved an AKC Herding Trial title (HS, HI, HX, HCH).

Entrants in the Herding classes must be intact. Spayed and neutered animals are not eligible. Winners of the above non-regular classes may also compete for Best of Breed, provided they are undefeated in any other class at this show.

BEST OF BREED COMPETITION (no defeated dogs will be allowed to compete)

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record. Dogs which according to their owners records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by AKC, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC....(Ch. 3, Sec. 13 AKC Rules Applying to Dog Shows)

SELECT DOG SELECT BITCH

AWARD OF MERIT: The maximum number of Award of Merit prizes will be one per ten Briards competing in the Best of Breed Competition, with a maximum of 6 prizes awarded at the Regional Specialty and a maximum of 10 prizes awarded at the National Specialty. BOB, BOS, Select Dog and Select Bitch are not eligible for Awards of Merit, but do count when calculating the number of Awards of Merit available.

BEST PUPPY IN SHOW: Will be awarded by the conformation judge immediately following the Award of Merit presentation. The winner of each of the four puppy classes (6-9 & 9-12, each sex) will compete for this Award. Puppies MUST be entered in one of those puppy classes to be eligible for this award. Should a puppy class winner go Best of Breed or Best of Winners it would be automatically awarded Best Puppy in Show. If a winner of a puppy class should go Winners Dog or Winners Bitch, only that puppy of its sex would compete against the puppies of the other sex.

BEST BRED BY EXHIBITOR IN SHOW: Award will also be given by the conformation Judge immediately following the awarding of Best Puppy in Show. The winner of each of the two BBE classes will compete

for the Award. Dogs must be entered in the BBE class to be eligible to compete. Should a BBE class winner go Best of Breed or Best of Winners, it would automatically be awarded Best BBE in Show.

BEST VETERAN IN SHOW: Award will also be given by the conformation Judge immediately following the awarding of Best Bred-By Exhibitor in Show. The winner of each of the six Veteran classes will compete for this Award. Dogs must be entered in one of the Veteran classes to be eligible to compete. Should a Veteran class winner go Best of Breed, it would automatically be awarded Best Veteran in Show

The above class winners must be ready to enter the ring following Best of Breed competition. WE WILL NOT HOLD UP JUDGING TO WAIT FOR THESE CLASS WINNERS.

Non-Regular Classes (Involving Multiple Dog Entries) CLASSES OFFERED AT NATIONAL SPECIALTY ONLY ON SEPTEMBER 23

NOTE: As the judge's decision in the Stud Dog, Brood Bitch, Brace Class is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class.

- STUD DOG CLASS For Stud Dogs and two (2) of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. - **BROOD BITCH CLASS** For Brood Bitches and two (2) of their Produce. Brood Bitches must be entered in the Brood Bitch Class and must be shown in the ring with their Produce. Owner of Brood Bitch need not necessarily be owner of Produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Produce must be entered individually in one of the Regular Classes or Veteran Classes, (provided the Produce has not been spayed or neutered), or Best of Breed Competition. See NOTE below.
- NOTE: Chapter 11, Section 8 of the Dog Show Rules provides that a "castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."
- BRACE CLASS Two Dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Dogs do not need to be entered in any other class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class."

The Briard Club of America will award at its National Specialty a three-point major to Reserve Winners Bitch if the Regular Class Bitch entry is twice the required number for a five-point major in the division where the National Specialty is held.

JUNIOR SHOWMANSHIP COMPETITION

- NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.
- OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.
- MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.
- NOVICE AND OPEN CLASS DIVIDED: Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

SANCTIONED FOUR-TO-SIX MONTH (BEGINNER PUPPY) COMPETITION

The Four-to-Six Month Puppy competition shall be for Briards that are four months of age and over but under six months on the day of the event. Entry fee is \$20.00. You must enter on the official AKC Entry Form, indicating in the space provided for "Classes" your entry in 4-6 Month Beginner Puppy. Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if they are registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must
 be handled by a non-professional handler. Professional handlers are defined as any person who
 belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise
 advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not
 be exhibited by current assistants and household members of a professional handler.
