Specific Sweepstakes Classes must be given on entry blank in space marked "Additional Class" as Sweepstakes Dog or Bitch and proper age classification. VETERAN SWEEPSTAKES – Open to all Siberian Huskies at least 8 year of age and older on the day of the show. Neutered or spayed dogs are eligible to compete in Veteran Sweepstakes. NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
