

OBSTACLES All obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials.

No practicing in the rings is allowed at any time. ALL DOGS MUST BE ON LEASH AT ALL TIMES EX-CEPT WHEN IN THE RING OR IN THE DESIGNATED WARM-UP AREA.

MOVE UPS As per Section 18, American Kennel Club Regulations for Agility Trials, dogs may be moved up to a higher class at the request of the owner as a result of qualifying for an agility title, provided the request is received by the trial secretary no later than **Tuesday**, **April 18, 2017 at 6:00 P.M. PDT.** Move-ups will be accepted by email or US Mail, but not by phone or fax.

MOVEUPS & CANCELLATIONS In order for move-ups and cancellations sent via email to be valid, exhibitors must receive an acknowledgement from the trial secretary. If you do not receive an acknowledgment, assume that your request has not been received. No refunds or changes will be made without the trial secretary's acknowledgement.


REFUNDS All refund requests received prior to the close of entries will be charged a \$5.00

processing fee. There will be no refunds after entries close except for bitches in season. See Notice to Exhibitors for information on Page 6.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner's) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

SITE INFORMATION

This trial will take place outdoors on a grass surface. **Ring size** will be a minimum of 100' x 100'.

Parking is free.

Multiple canopy tents will be provided for crating.

Food may not be sold at Delta Park where Draft and Agility are being held. If you are attending any of these events, you can pre-purchase your lunch through Master Registration. Wristband is required for lunch pickup. On Tuesday there will be a food truck (final selection to be announced prior to Master Registration deadline). \$11 for lunch which will include soda or water.

NOTICE TO EXHIBITORS & TRIAL REGULATIONS

PLEASE INCLUDE A COPY OF YOUR JUMP HEIGHT CARD WITH YOUR ENTRY

ONLINE ENTRIES will not be accepted for this trial

THE SAFETY of dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

THE TRIAL will be open from 8 a.m. to 3 p.m.

RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned check.

TELEPHONE, FAX, AND UNSIGNED ENTRIES cannot be accepted.

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE. ENTRIES RECEIVED WITHOUT FEES** will not be accepted.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECI-FIES ANY CONDITIONS AS TO ITS ACCEPTANCE. Express mail entries must include signature permitting them to be left at the secretary's address without recipient's signature.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, extreme weather, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

ERRORS ON ENTRY BLANKS-Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after trial has closed.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. The owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for

the purpose of calling or locating dogs that are not brought into the ring when required.

DOGS PRESENT will not be permitted to roam. Exhibitors are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior, may, at the discretion of the trial committee, be asked to leave the show site. In such cases, no refund of any fees will be made. All dogs present must be held on leash or confined to their crate at all times except when in the ring or when in the designated agility warm-up area. The site will be monitored and offenders will be asked to leave. In such cases, no refunds will be made. Dogs must use the designated exercise area.

TRIAL COMMITTEE will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

BITCHES IN SEASON shall not be eligible to participate. Bitches unable to compete for this reason will be refunded upon presentation of a veterinarian certificate. This certificate must be presented to the Trial Secretary prior to the start of judging on the day of the trial.

DOGS PARTICIPATING must be 15 months of age or older and must be registered with the American Kennel Club, have an AKC Limited Registration, PAL/ILP and an AKC DNA profile num- ber. Dogs must be physically sound. Dogs that are blind shall not be eligible. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes.

ACKNOWLEDGEMENT OF ENTRIES will be made as soon as trial closes. Acknowledgment of entries will include confirmation notices.

The Bernese Mountain Dog Club of America, Inc. and East Delta Park will not be responsible for any lost or damaged items left at the show site.

In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person, I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and is binding on me (us).

INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and <u>may not</u> compete in a jump height division <u>higher or lower</u> than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by *a* Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by *a* Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767.
