**VETERAN SWEEPSTAKES** – Open to all Siberian Huskies at least 8 year of age and older on the day of the show. Neutered or spayed dogs are eligible to compete in Veteran Sweepstakes. Dogs shown in Veteran Sweepstakes need not be entered in one of the regular or veteran classes. NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.
