Thursday, May 30 - 30 minutes after end of Obedience Trial to 7:00PM

Friday, May 31 - 30 minutes after end of Obedience Trial to 7:00PM

\$5.00 for seven (7) minutes of individual ring time.

Novice group stays (at no additional charge) after approximately every six dogs.

The club will provide a timer. Exhibitors must set up jumps and provide their own "judge" if desired. Thursday match available on FIRST-COME, FIRST-SERVED BASIS. Sign-up sheets for Friday match will be available at noon at the stewards' table in the obedience ring. You can sign up immediately prior to the Friday match, if there is time available. Time will be reserved on a FIRST-COME, FIRST-SERVED BASIS. You may not use consecutive time slots. For example, if you want 14 minutes, you must sign up in seven minute increments, allowing someone else to have a turn before you repeat. Ending times are nonnegotiable. You pay no fee until you are ready to have the ring set up. Your seven minutes begin when you and your dog walk into the ring. You may use your seven minutes to do run-throughs, exercises or parts of exercises, play, train or stays. Any regular or non-regular classes can be run-through. Verbal praise, corrections and gentle guiding are allowed (harsh corrections are not allowed). Food, toys & training aids are allowed, but you must pick up any food dropped on the mats. You may work with a helper.

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. Select Dog and Select Bitch, where applicable, will be chosen immediately following Best of Breed competition. This will be followed by Best Owner-Handled.

Veterans Special Attraction Classes – Sunday Only

VETERAN DOGS VETERAN BITCHES

A class for dogs and a class for bitches seven (7) years of age and older. Entrants may be spayed or neutered. **Winners are NOT eligible for Best of Breed competition by virtue of having won this class.** See additional information below.

Best Bred by Exhibitor Competition

Best Bred by Exhibitor will be awarded from the First Place winners in the Bred by Exhibitor classes immediately following each breed. If the Best of Breed is awarded to a dog/bitch coming from a Bred by Exhibitor Class for that breed, the Best Bred by Exhibitor win is automatic. Best Bred by Exhibitor Group judging will take place in a ring adjacent to the regular Group ring. First through Fourth Place in each Group will be awarded, with the Group Winner going on to Best Bred by Exhibitor in Show. Judges for Best Bred by Exhibitor in Breed will be as published for the regular classes. Bred by Exhibitor Group and Best Bred by Exhibitor in Show judges will be announced on the judging program. Best Bred by Exhibitor in Show will be judged following Best in Show judging.

AKC NATIONAL OWNER-HANDLED SERIES - ALL FOUR DAYS

The purpose of the AKC National Owner-Handled Series (NOHS) is to recognize and showcase the quality dogs being exhibited by owner/handlers and to provide a venue for the owner/handlers to compete against their peers. The determination of the awards in the AKC National Owner-Handled Series is based solely on the quality of the entry. The owner/handler's handling ability is not of consideration.



- Dog must be marked as eligible to compete in the AKC NOHS prior to the closing of entries. There is no additional fee to enter this competition.
- Dogs must be handled by an eligible owner/handler for the AKC NOHS throughout the breed level (all classes, Winners, and Best of Breed) competition. Additionally, dogs must be handled by an eligible owner/handler for all AKC National Owner-Handled Series competition (Group and Best in Show). Any person may exhibit the dog in the regular Group and Best in Show competitions.
- Exhibitors must declare their dog AKC National Owner-Handled Series eligible at the time of entry using the check box on the entry form. The handler must be an owner of record according to the AKC's records as of the date of the show. Dogs declared eligible will be identified by an asterisk or other representative mark in the judge's book, steward's book, and the show catalog.
- *Professional handlers, household members & current assistants to professional handlers may not exhibit.
- The Owner-Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non-regular classes. This excludes all dogs defeated during class and winners competition for the regular show.

**Professional handler is defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Eligibility restrictions apply to all members of the same household. Household members and current assistants to professional handlers in conformation are not eligible to exhibit in this competition. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend. Eligibility restrictions apply to all members of the same household.*

USE OF RAMPS – ALL BREEDS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required. The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotto Romagnolo, American Water Spaniels, Clumber Spaniels, English Springer Spaniels, Field Spaniels, Welsh Springer Spaniels, Cirneco dell'Etnas, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Keeshonden, Entlebucher Mountain Dogs, Finnish Lapphunds, Icelandic Sheepdogs, Norwegian Buhunds, Polish Lowland Sheepdogs, Spanish Water Dogs, Mudi (Misc.) and Norrbottenspets (Misc.).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels and Whippets.

The following breeds must be judged on a ramp through all levels of conformation competition: Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei and Chow Chows. This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions. Ramps can be used in emergency situation to judge any breed.

In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds. (01/2019)



JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Entry and Eligibility

Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.
