The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- The American Kennel Club will collect: a \$3.00 Event Service Fee and \$.50 Recording Fee where applicable for the first entry of a dog, plus a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single-entry classes, in all AKC licensed and member club events. At every licensed or member club rally trial, a recording fee of \$3.50 is required for the first entry of each dog and a recording fee of \$3.00 is required for each additional entry of the same dog.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Clubs is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES – Fax entries will be accepted up to closing time. Fee is \$4.00 per dog per show. If the credit card charge is denied for any reason, an additional service charge of \$20.00 will be added. FAX NUMBER: 360-755-2248. This is for Fax Machine ONLY. Incomplete or illegible Fax entries are not acceptable as a valid entry in a show. Proof of transmission is not proof of receipt of a legible or complete transmission (under AKC Rule Ch. 11, Sec. 4). A Fax-Friendly entry blank PDF is available for download at www.BarayEvents.com
- Entries will be acknowledged after entries close with entry acknowledgment and judging program to address on entry. Should Exhibitor NOT receive an acknowledgment within a reasonable time, PLEASE notify BaRay Events at 360-755-7086 or email dogshows@barayevents.com.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Chapter 11, Section 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- Only dogs eligible for these shows will be admitted into the show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- PUBLICATION RIGHTS – By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

FROM DENVER & DENVER INTERNATIONAL AIRPORT: West on I-70 to Hwy 270 (Fort Collins) to I-25 North (approx. 30 miles) to EXIT 257, Hwy 34 (W) Loveland. Turn Left (W) on Hwy 34 then go .54 mi to Rocky Mountain Ave. Turn Right onto Rocky Mountain Ave. Pass straight through One Roundabout. At the next Roundabout, take the First Exit onto McWhinny Blvd. Residence Inn by Marriott Loveland Fort Collins, 5450 McWhinney Blvd is on the Right.

WINNERS DOG WINNERS BITCH
BEST OF BREED (VARIETY) COMPETITION

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. Select Dog and Select Bitch, where applicable, will be chosen immediately following Best of Breed competition. This will be followed by Awards of Merit (up to four), NOHS Best of Breed, Best Puppy in the Regular Puppy Classes, Best in the Veterans Classes, Best in the Bred-By Exhibitor Classes, Best in the Hunting Retriever Classes, and Best in the Working Retriever Classes.

RESERVE WINNERS DOG & BITCH: Nova Scotia Duck Tolling Retriever Club (USA) will designate the Reserve Winners Dog and the Reserve Winners Bitch to be awarded a three (3) Point major, provided the criteria set forth in Chapter 16, Section 1 of the Rules Applying to Dog Shows is met. The number of dogs competing in the regular classes of the Reserve Winners sex must total at least twice the number required for a five (5) point major, in the region in which this event is held. No Major for Reserve Winners shall be given based upon an award of Best of Winners. In counting the number of dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge or from which all awards are withheld, shall not be included.

BEST PUPPY IN THE REGULAR PUPPY CLASSES: The First Place Winners from the individual Regular Puppy Classes (6-9 mos. And 9-12 mos.) will compete for the award of Best Puppy in the Regular Classes. Best Puppy competition will follow Best of Breed judging.

BEST BRED-BY-EXHIBITOR IN THE BRED-BY-EXHIBITOR CLASSES: The First Place Winners from the individual Bred-By-Exhibitor Classes will compete for the award of Best Bred-By-Exhibitor. Best Bred-By-Exhibitor competition will follow Best of Breed judging.

BEST IN THE VETERAN CLASSES: The First Place Winners from the Veteran Classes will compete for the award of Best Veteran. Best Veteran competition will follow Best of Breed judging.

BEST IN THE HUNTING RETRIEVER CLASSES: The First Place Winners from the Hunting Retriever Classes will compete for the award of Best Hunting Retriever. Best Hunting Retriever competition will follow Best of Breed judging.

BEST IN THE WORKING RETRIEVER CLASSES: The First Place Winners from the Working Retriever Classes will compete for the award of Best Working Retriever. Best Working Retriever competition will follow Best of Breed judging.

AWARDS OF MERIT: Awards of Merit will be awarded after Best of Breed judging is completed to Nova Scotia Duck Tolling Retrievers in Best of Breed competition that exemplify the breed's characteristics. These awards are reserved for those quality animals the judge feels are worthy of final consideration for Best of Breed. The dogs selected for Best of Breed and Best of Opposite Sex to Best of Breed, Select Dog and Select Bitch are not eligible for an Award of Merit. At judges discretion, up to four (4) awards will be awarded in the Best of Breed competition, which shall include move-ups, Winners Dog, Winners Bitch, and first place in Veteran Dog Classes, Veteran Bitch Classes, Hunting Retriever Dog, Hunting Retriever Bitch, Working Retriever Dog, and Working Retriever Class Bitch Classes.

NON REGULAR CLASSES INVOLVING SINGLE ENTRIES

Because WINNERS of these classes will compete for Best of Breed, all entrants MUST also meet ALL American Kennel Club requirements for Non-Regular Classes involving single dog entries. The following classes are divided by sex.

VETERAN 7-10 YRS DOGS	VETERAN 7-10 YRS BITCHES

Veteran 7-10 Yrs: A class for Dogs/Bitches 7 years old and under 10 years.

Veteran 10 Yrs & Over: A class for Dogs/Bitches 10 years old and over.

Hunting Retriever: A class for Dogs/Bitches that have a Working Certificate Excellent (WCX) from the NSDTRC (USA) or an AKC Senior Hunter title (SH) or Master Hunter title (MH). Dogs/Bitches must be intact - no spayed or neutered dogs are allowed. Class shall be divided by sex.

Working Retriever: A class for Dogs/Bitches that have earned a NSDTRC (USA) WC or WCI or an AKC Junior Hunter Title (JH) or higher. Dogs/Bitches must be intact - no spayed or neutered dogs are allowed. Class shall be divided by sex.

Winners of the above non-regular Classes will be eligible to compete for Best of Breed if otherwise undefeated.

NOTE: If a dog is entered in a Non-Regular class and Best of Breed and is defeated in the Non-Regular class the dog can NOT be shown in Best of Breed.

NON-REGULAR CLASSES, INVOLVING MULTIPLE ENTRIES

STUD DOG CLASS: For Stud Dogs and two of their Get. Stud dog must be entered in the Stud Dog Class and shown in the ring with their Get. Owner of the Stud Dog need not necessarily be the owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in a regular class, Best of Breed, or some other non-regular class. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

BROOD BITCH CLASS: Same as above, except substitute "Brood Bitch" for "Stud Dog, and "Produce" for "Get."

BRACE (Conformation): The dogs comprising a Brace MUST be named at time of entry. If a dog, which is part of a Brace, is not entered in another class, it must be entered for "Brace Class Only". In making entries for "Brace Class Only", full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes, "Brace Class". If more than one Brace is entered by the same owner, the dogs comprising EACH Brace must be so designated, "Brace No. 1", "Brace No. 2", etc. Per AKC RULES, CHAPTER 3, SECTION 17: Dogs competing in brace competition must have at least one common owner.

NOTE: As the judge's decision in the Stud Dog/ Brood Bitch/Brace Class is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in this class will be eligible to compete for Best of Breed by virtue of having won this class.

4-6 MONTH BEGINNER PUPPY COMPETITION

One combined class will be offered for Nova Scotia Duck Tolling Retrievers that are (4) four months & under (6) six months old on Friday, October 18, 2019. An AKC registration number or AKC litter number will be required for all entries. A foreign-born dog may enter this class if they are registered in the country of origin.

Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized.

Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show, or any show during a cluster/weekend.

AKC Rules in Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise. Exhibitors should plan on opening the mouth of their puppy for the judges. Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this Competition.

CLASSIFICATION – CLASSES COMBINED: Puppy, 4 & Under 6 months

NO PUPPIES UNDER THE AGE OF SIX (6) MONTHS, EXCEPT THOSE PARTICIPATING IN THE 4-6 MONTH PUPPY COMPETITION, MAY BE ON THE GROUNDS.

OBEDIENCE TRIAL CLASSES

REGULAR CLASSES – Novice A & B, Open A & B, Utility A & B

OPTIONAL TITLING CLASSES – Beginner Novice A & B, Graduate Novice, Graduate Open

NON-REGULAR CLASSES – Veteran, Brace, Team

VETERANS CLASS: The Veterans Class will be for dogs that have an obedience title and are at least 7 years old on the date of the trial. The exercises will be performed and judged as in the Novice Class. Dogs may be entered in another class or classes.

BRACE CLASS (Obedience): The Brace Class will be for two dogs of the same breed that are eligible under these Regulations and capable of performing the Novice exercises. PER AKC OBEDIENCE REGULATIONS CHAPTER 20 NON-REGULAR CLASSES, SECTION 5: The dogs need not be owned by the same person but will be handled by one handler. Dogs may be shown unattached or coupled (the coupling device will not be less than 6 inches in overall length). Whichever method is used will be continued throughout all exercises. Dogs may be handled by the owner or any other person, need not be entered in another class at the same trial, and need not have obedience titles. A separate official entry form will be completed in full for each dog entered.

Please identify which dogs are members of the brace on each entry form. If more than one brace designate "Brace 1", "Brace 2", etc. For online entries of more than one Brace, please send an email to dogshows@barayevents.com, reference the show and the Reg Numbers of the paired dogs.

TEAM CLASS: The Team class will be for teams of any four dogs that are eligible under these regulations. Five dogs may be entered, one to be considered an alternate for which no entry fee will be required. However, the same four dogs will perform all exercises. Dogs may be handled by the owner or any other person, need not be entered in another class at the same trial, and need not have obedience titles. A separate official entry form will be completed in full for each dog entered. No dog may be entered on more than one team.

Please identify which dogs are members of the Team on each entry form. If more than one Team designate "Team 1", "Team 2", etc. For online entries of more than one Team, please send an email to dogshows@barayevents.com, reference the show and the Reg Numbers of the paired dogs.

RALLY TRIAL CLASSES – RALLY RING WILL BE 40' X 50'

REGULAR CLASSES - Novice A & B, Intermediate, Advanced A & B, Excellent A & B, Master

OBEDIENCE & RALLY EXHIBITORS: MOVE-UPS WILL BE ACCEPTED FOR THESE TRIALS ACCORDING TO CH. 1, SEC. 16, OBEDIENCE REGULATIONS.

JUMP HEIGHT MUST BE INDICATED ON ALL APPLICABLE **OBEDIENCE & RALLY CLASSES**

REFUNDS: Bitches in Season: Refund of all but \$10.00 of the entry will be made for Bitches entered in Obedience and Rally Classes who come in season after entries close. Request in writing must be submitted to the Superintendent with certificate from a Veterinarian no later than 30 Minutes before regular class judging of that trial.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

Competition must exist for Best Junior Handler to be awarded.

After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

ELIGIBILITY: Nova Scotia Duck Tolling Retrievers only, at least 6 months old on the day of the show. Bitches in season are not eligible.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

GENERAL SWEEPSTAKES INFORMATION

Professional Handlers may NOT show dogs in any of the Sweepstakes Events at the NSDTRC(USA) National Specialty and shall abide by the AKC definition of a Professional Handler defined as follows: "any person who belongs or has belonged to a professional handlers organization, distributed rate cards or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Compensation for expenses outside of the conformation ring does not meet this definition."

SWEEPSTAKES

The Nova Scotia Duck Tolling Retriever Club (USA) Sweepstakes is open to all Nova Scotia Duck Tolling Retrievers who, on the day of the show will be over six (6) months and under eighteen (18) months of age. Champions of Record may be entered in the Sweepstakes classes. All dogs entered in the Sweepstakes must also be entered in a regular class at the regular entry fee.

SPECIALTY CHALLENGE TROPHIES

BEST VETERAN CHALLENGE TROPHY

This trophy is an etched image of a Toller coming out of the water with a retrieved duck. This trophy is offered in memory of Robert Hoch by Dee Nichols (KD's Kennels) and Laura White (Cinnstar Retrievers) for the Best Veteran at the NSDTRC (USA) National Specialty. This trophy is offered on a three-time win basis, and permanent possession of the trophy will be awarded permanently to any owner who wins the trophy three times at three different National Specialty Shows, not necessarily with the same dog.

BEST PUPPY PERPETUAL TROPHY

The trophy is a two-tiered wood base of natural-color cherry wood. A crystal block with a 3-dimensional image of a Toller will adorn the top of the trophy. The crystal block is illuminated from within the trophy with lighting. This trophy is offered by Jamie Como and Kathy Koebensky-Como for the Best Puppy at a NSDTRC (USA) National Specialty, after they have won Best Puppy three times at previous National Specialties to become permanent owners of the Sagewood Kennel Best Puppy Challenge Trophy. This trophy is offered on a three-time win basis, and possession of the trophy will be awarded permanently to any owner who wins the trophy three times at three different National Specialty Shows, not necessarily with the same dog.

HIGH IN TRIAL OBEDIENCE CHALLENGE TROPHY

This trophy is a silver cup on a wooden base. This High in Trial trophy is offered by Lonetree Kennels through the NSDTRC (USA). This trophy is offered on a three-time win basis, and permanent possession of the trophy will be awarded to any owner who wins the trophy three at three different National Specialty Shows, not necessarily with the same dog.

NSDTRC (USA) SPECIAL AWARDS

The following Awards are presented by the Nova Scotia Duck Tolling Retriever Club (USA) through the generosity of members and friends. These awards are for achievements during the previous year(s) and are presented at the Annual Awards Banquet.

RUSTY JONES AWARD

Each year at the NSDTRC (USA) Annual Awards Banquet, the club recognizes our most versatile dogs by presenting them with the Rusty Jones Award. The award is named after CH Sylvan's Rusty Jones CDX WC, one of our earliest versatile Tollers. To be eligible, a dog must have earned an NSDTRC (USA) Championship, an NSDTRC (USA) or AKC Companion Dog title and an NSDTRC (USA) Working Certificate. Titles may be earned over several years. To receive the award this year, the last title must have been completed by June 30, 2019.

SYLVAN KENNEL AWARD

Each year Lennoxlove Kennel will award the Sylvan Kennel Award to the Toller who has earned the highest average score of the first three qualifying scores towards an American Kennel Club obedience title, up through and including the UD title. The award for this year will go to the dog who earned the highest average score between July 1, 2018 and June 30, 2019.

TENDERFOOT OBEDIENCE AWARD

Each year, Region 2 will give an Award to the highest scoring dog/handler team at the National Specialty show in the Novice A obedience class.

This award was originally conceived by Evelyn Williams as a way to encourage Toller owners to become involved with obedience competition with their dogs. Evelyn became involved in Tollers in 1989, and during her lifetime trained her Tollers to the highest level in obedience and in the field. Evelyn was a wonderful obedience trainer and handler, and was always in contention for HIT awards. Obedience was one of her favorite dog sports because of the teamwork involved, and because of the foundation it provides any future work in the field.

After the completion of the Novice A class, a representative from Region 2 will review each Toller's score entered in the class to determine the winner. The Tenderfoot Award will then be given out by a representative of Region 2 at the 2019 Annual Awards Banquet or at another gathering following the Obedience trial.

EVELYN WILLIAMS AWARD OF EXCELLENCE

Annually, the club offers the Evelyn Williams Award of Excellence as a means of recognizing members of the NSDTRC (USA) that own and handle their Tollers to the highest levels of titling and achievement. Titles and/or achievements in conformation, obedience, field tests, field trials, tracking, and agility are venues in which the owner/ handler may qualify for this award. Examples of titles include the UD, WCX, MHR, TDX, and the various agility titles awarded at the highest levels. Examples of achievements that may qualify the owner/handler for the award are Best in Specialty, Best in Show at an all-breed event, or High in Trial (score of 195 or greater). There are contingent rules surrounding most of the achievements, so read the rules carefully.

ADMIRAL HALSEY HOT DOG TEAMWORK AWARD

Each year the Admiral Halsey Hot Dog Teamwork Award will be given to each team of Toller and Owners(s) who have completed all their training and hunt tests or field trials together and achieved any level of an AKC field title: Junior Hunter, Senior Hunter, Master Hunter, Field Champion or Amateur Field Champion. Owner(s) refers to all co-owners of the dog.

RISING STAR AWARD

Each year Sydney Jones-Juckett and Stuart Juckett will award the Rising Star Award to the owner of the brood bitch that produced the most AKC champions in the previous calendar year. The award would be based on AKC and Pedigree statistics, over the course of a calendar year of January through December, which would be calculated by the NSDTRC (USA) statistician.

STRUAN AWARD

This is a perpetual trophy to be awarded to the NSDTRC (USA) member-handler of the oldest dog of either sex to earn a Working Certificate Intermediate at a NSDTRC (USA) Hunt Test. To be eligible for the award, a dog must be five (5) years old or older on the day of the test and not have earned a title in any field-testing program at a level that involves a double marked retrieve.

ROY'LL FLUSH AWARD

Award given to any Toller that earns both an AKC MH title and an AKC CH title in which the owner has been a member in good standing for a minimum of one year. The awards will be presented to those eligible during the previous eligibility period (July 1 - June 30) at the Annual Awards Banquet. CODE OF ETHICS

In keeping with the Bylaws and philosophy of the Club, to protect and further the advancement of the Nova Scotia Duck Tolling Retriever, the following Code of Ethics has been established:

Code of Ethics

Nova Scotia Duck Tolling Retriever Club (USA)

Approved 1996

1. I subscribe to the purpose of the NSDTRC (USA) as set forth in the Bylaws and will abide by the rules set down by the Club.
2. I will acquaint myself with the NSDTRC (USA) approved Breed Standard for the NSDTR (Toller), and with principles of good health and grooming for the breed.
3. I will exhibit sportsman like conduct that will reflect on me and on the breed at all competitions, and will encourage others to do so. I will refrain from public criticism and malicious degrading of others and their dogs.
4. I will ensure humane treatment, including proper feeding, maintenance, health care and training, for all my animals and will encourage other to do the same.
5. I will commit myself to continuing education in matters pertaining to the care and training of the Toller.
6. If I breed, I will strive to improve the Toller breed according to the NSDTRC Breed Standard. I will conscientiously plan each breeding, choosing only parents of appropriate temperament, appearance and other desirable qualities.
7. I will become aware of genetic defects that can be harmful to the breed. When breeding, I will endeavor to select animals that will reduce the incidence of genetic problems while enhancing the positive attributes and abilities of the breed. I will be open with all persons interested in the welfare of the Toller and will discuss possible physical or temperament defects in my own stock.
8. I will act responsibly in regards to all puppies produced by my breeding for the lifetime of the puppies.
9. I will never knowingly sell to, or place a Toller with unethical persons or those who would not provide proper and humane care to the dog. I will refuse to sell any Toller to any pet shop or to any wholesale dealer in dogs.
10. Should I become aware of the mistreatment, abuse, or need for relocation of any Toller, I will make every effort to be of assistance by notifying the breeder of the dog involved and the appropriate local authorities, and I will assist in any other manner in which I am able.

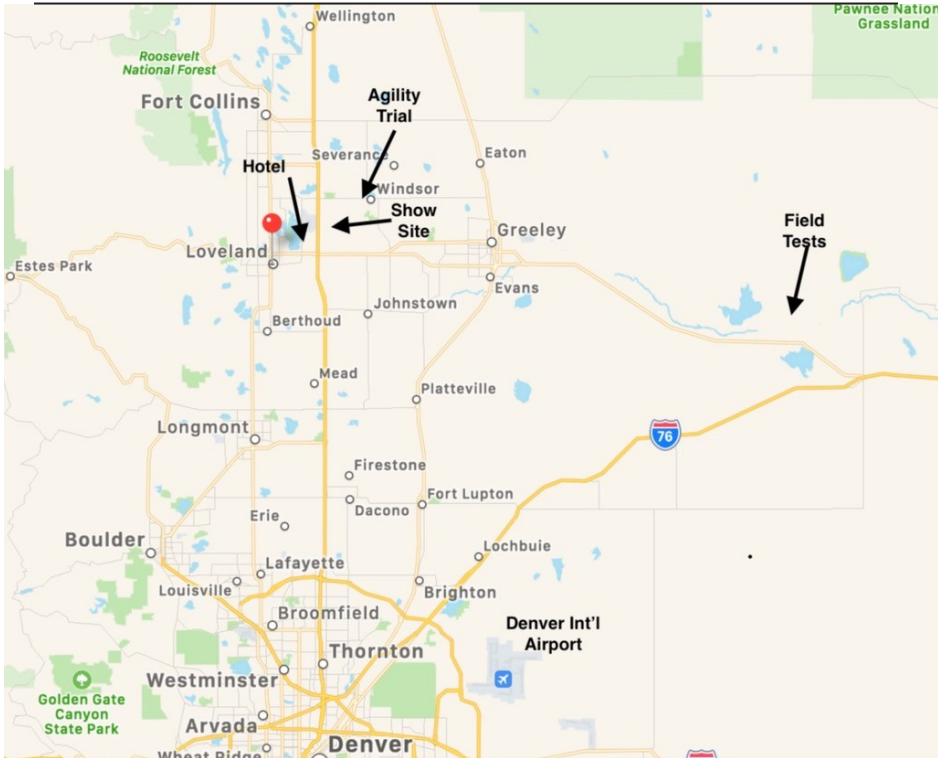
