

– NOTICE TO EXHIBITORS –

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- The AKC will collect a \$1.50 AKC Event Service Fee and 50 cent Recording Fee for the first entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered in more than one class in the show, the Event/Recording Fees to be collected on the first entry only. (AKC Rule. Ch. 11, Sec. 2). In accordance with AKC Rally regulations, the AKC will collect a \$3.00 per entry of dog Rally Event Service Fee. A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for AKC.
- CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and/or its Superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR THE COMPLETENESS OF ENTRY RESTS SOLELY WITH THE ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Superintendent will add a \$20.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- FAX ENTRIES – Fax entries will be accepted up to closing time. Fee is \$4.00 per dog per show. If the credit card charge is denied for any reason, an additional service charge of \$20.00 will be added. FAX NUMBER: (360) 683-6654. This is for Fax Machine ONLY. Incomplete or illegible Fax entries are not acceptable as a valid entry in a show. Proof of transmission is not proof of receipt of a legible or complete transmission (under AKC Rule Ch. 11, Sec. 4). - ENTRIES WILL BE ACKNOWLEDGED after entries close with entry acknowledgment and judging program to address on entry. Should Exhibitor NOT receive an acknowledgment within a reasonable time, PLEASE notify the Superintendent at (360) 683-1507 or email [dogshows@barayevents.com](mailto:dogshows@barayevents.com).
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund of entry fee for bitches in season. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. The Superintendent will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Dogs must be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- Only dogs eligible for these shows will be admitted into the show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. (Please note; Dogs whelped in Canada and not individually registered in the U.S. are eligible for the following classes: 6-9 mos., 9-12 mos, 12-18 mos., Novice, & Open. Dogs MUST have a CKC individual registration.)

### Non-Regular Classes (Involving Single Dog Entries)

Veteran Dogs    Veteran Bitches

A class for dogs and a class for bitches, 6 years of age and older. Entrants in Veterans need not be intact. spayed and neutered animals are eligible. Winners of the Veterans Classes, if otherwise undefeated at this show, compete for Best of Breed.

**BEST OF BREED COMPETITION:** The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and dogs that according to their owners records have completed the requirements for a Championship but whose Championships are unconfirmed. The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owner's records.

Best Puppy from the Regular Puppy Classes • Best from the Bred by Exhibitor classes

### Non-Regular Classes (Involving Multiple Dog Entries)

**STUD DOG.** For Stud Dogs and two of their get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their get. The owner of the Stud Dog need not necessarily be owner of the get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for the breed. Get must be entered in a regular class, Best of Breed competition or some other non-regular class. Entry fee is \$25.00 for the Unit, or \$18.00 as an additional class.

**BROOD BITCH.** For Bitches and two of their produce. Brood Bitches must be entered in the Brood Bitch Class and must be shown in the ring with their produce. The owner of the Brood Bitch need not necessarily be owner of the produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for the breed. Produce must be entered in a regular class, Best of Breed competition or some other non-regular class. Entry fee is \$25.00 for the Unit, or \$18.00 as an additional class.

**BRACE CLASS:** Two dogs that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. The Dogs comprising a Brace MUST be named at the time of entry. Entry fee for Brace Class as a UNIT is \$18.00. In making entries for "Brace Class Only" full particulars MUST be given for each dog on individual entry forms. An entry form for a dog entered in a Regular Class or for "Best of Breed Competition" and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes, "Brace Class." If more than one Brace is entered by same owner, dogs comprising EACH BRACE must be designated "Brace No. 1," Brace No. 2," etc.

*NOTE: As the judge's decision in the Brace Class is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.*

## SWEEPSTAKES

A Sweepstakes will be held in conjunction with this Specialty. Sweepstakes will be judged prior to the Regular Classes. All dogs and bitches entered in Sweepstakes MUST ALSO be entered in a Regular Class at this Specialty, at the regular entry fee. The Sweepstakes is open to all dogs/bitches who are at least 6 months of age and under 18 months of age on the day of the show. Champions of Record at the time that entries close are not eligible for the Sweepstakes. Entries must be made at the same time and on the same entry form as the regular classes, indicating in the space for "Additional Classes" your entry in Sweepstakes.

## JUNIOR SHOWMANSHIP COMPETITION

**NOVICE CLASS:** For Boys and Girls who, at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**OPEN CLASS:** For Boys and Girls who, at the time entries close, have won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**NOVICE AND OPEN CLASSES DIVIDED:** **Junior** - 9 years and under 12 years old on the day of the show; **Intermediate** - 12 years and under 15 years old on the day of the show. **Senior** - 15 years and under 18 years old on the day of the show.

**NOTICE:** Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 816-3776.

**BE SURE ALL INFORMATION** for Junior Showmanship Classes is entered on front and back of entry form.

**NOTICE TO EXHIBITORS REGARDING CORRECTIONS OR CHANGES TO ENTRIES:** Corrections other than the specific changes listed in Ch. 11, Sec. 6 (i.e. sex of a dog, transfers between age specific classes, and "move-up's" to BOB or BOV) are the only changes to the entries superintendents or secretaries are authorized to make after closing of entries. Owners are responsible for errors in the entry forms, regardless of who may make such errors. **THIS RULE IS BEING STRICTLY ENFORCED BY THE AMERICAN KENNEL CLUB. PLEASE CHECK YOUR ENTRIES CAREFULLY.** Corrections to entries may be made by the Superintendent prior to the closing of entries if such correction is submitted in writing. Exhibitors are required to report any changes/corrections after closing directly to the American Kennel Club.
