DDBSA Members Breeder Class. Entry fee \$20. The “DDBSA Member Breeders Class” is open to DDBSA Members only. This class will be held on Sunday after Best of Breed by the National Judges. No minimum entries. To enter, a DDBSA member breeder presents four dogs bred by them (i.e. they are the owner or co-owner of the dam of any litter(s)). The minimum age for dogs entered is 6 months of age, and must be entered in the DDBSA National Sanctioned A Match in any of the classes. Please indicate Kennel Name on back of entry blank.

Stud & Brood Dog Class. Entry Fee \$30. Stud dogs (or brood bitch) and two of their Get (or produce). Dogs must be entered in the Stud Dog / Brood Bitch class and shown in the Ring with two of their offspring. Stud Dog owner need not be owner of the offspring. While the merits of the Stud or Bitch are not to be considered in the placement of the entry, they must be examined to determine if it has a condition that would require disqualification or excusal under Dog Show rules or the standard of the breed. Offspring must be entered in the DDBSA National Sanctioned A Match in any of the classes
