

### BEST BRED BY EXHIBITOR COMPETITION – SATURDAY ONLY

Best Bred By Exhibitor will be awarded from the First Place winners in the Bred By Exhibitor Classes ONLY immediately following each breed. If the Best of Breed is awarded to a dog/bitch coming from the Bred By Exhibitor Class for that breed, the Best Bred By Exhibitor win is automatic. Best Bred by Exhibitor Group will be judged following the Variety Group that included that breed. First through Fourth Place in each Group will be awarded, with the Group Winner going on to Best Bred By Exhibitor in Show. If the dog/bitch judged First in their respective regular group was also the Best Bred by Exhibitor for their breed, first place in the BBE Group is automatic, and judging will be for second through fourth places only. Judges for Best Bred by Exhibitor in Breed and Best in Show will be as published for the regular classes. Bred by Exhibitor Group judges will be announced the day of the show.

## BREEDS WITH OPEN CLASS DIVISIONS AT THESE SHOWS

### OPEN CLASS DIVISION *MUST* BE INDICATED ON ENTRY BLANK

**Retrievers (Labrador):** Open Classes Divided, Both Sexes: Black; Chocolate; Yellow.

**Dachshunds (Longhaired):** Open Classes Divided, Both Sexes: Miniature (under 11 lbs. & 12 mos. old or over); Standard (11 lbs. & over and under 11 lbs. if less than 12 mos. old).

**Dachshunds (Smooth):** Open Classes Divided, Both Sexes: Miniature (under 11 lbs. & 12 mos. old or over); Standard (11 lbs. & over and under 11 lbs. if less than 12 mos. old). Open Standard Classes Divided, Both Sexes: Black & Tan including any other color except Red; Red.

**Dachshunds (Wirehaired):** Open Classes Divided, Both Sexes: Miniature (under 11 lbs. & 12 mos. old or over); Standard (11 lbs. & over and under 11 lbs. if less than 12 mos. old).

**Boxers:** Open Classes Divided, Both Sexes: Brindle; Fawn.

**Bullmastiffs:** Open Classes Divided, Both Sexes: Brindle; Any Other Allowed Color.

**Doberman Pinschers:** Open Classes Divided, Both Sexes: Black; Any Other Allowed Color.

**Great Danes:** Open Classes Divided, Both Sexes: Brindle, Fawn, Blue, Black, Harlequin, Mantle.

**St. Bernards:** Open Classes Divided, Both Sexes: Longhaired; Shorthaired.

**Pugs:** Open Classes Divided, Both Sexes: Black, Fawn.

**Chinese Shar-Pei:** Open Classes Divided, Both Sexes: Brush Coat; Horse Coat.

**Australian Shepherds:** Open Classes Divided, Both Sexes: Blue Merle; Black; Red Merle; Red.

**Collies (Rough):** Open Classes Divided, Both Sexes: Blue Merle; Sable & White; Tri-Color; White.

**Shetland Sheepdogs:** Open Classes Divided, Both Sexes: Sable & White; Any Other Allowed Color.

**NOTICE TO EXHIBITORS REGARDING CORRECTIONS OR CHANGES TO ENTRIES:** Corrections other than the specific changes listed in Ch. 11, Sec. 6 (i.e. sex of a dog, transfers between age specific classes, and "move-up's" to BOB or BOV) are the only changes to the entries superintendents or secretaries are authorized to make after closing of entries. Owners are responsible for errors in the entry forms, regardless of who may make such errors. **THIS RULE IS BEING STRICTLY ENFORCED BY THE AMERICAN KENNEL CLUB. PLEASE CHECK YOUR ENTRIES CAREFULLY.** Corrections to entries may be made by the Superintendent prior to the closing of entries if such correction is submitted in writing. Exhibitors are required to report any changes/corrections after closing directly to the American Kennel Club.

### ENTRIES, CANCELLATIONS, CHANGES, TRANSFERS

**FAX ENTRIES:** Fax number: 360-683-6654. \$4.00 per dog per show added for FAX-Credit Card entries. Both sides of entry form must be transmitted. Entries must be accompanied by a cover sheet stating the number of pages, what shows and how many dogs per show. Visa, MasterCard, and American Express are accepted for Fax entries. Credit card information (Credit Card number, expiration date, and cardholder name) must be on cover sheet. Note: Visa and MasterCard users – You must include the 3-digit security code that appears above your signature on the back of the card. Proof of fax transmission is not proof of receipt of a legible or complete transmission (under AKC Rule Ch. 11, Sec. 4). ### USE OF RAMPS

At the discretion of the judge, the following breeds may be judged on a ramp: Clumber Spaniels, Sussex Spaniels, Basset Hounds, Whippets, Irish Terriers, Kerry Blue Terriers, Staffordshire Bull Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden and Polish Lowland Sheepdogs. Ramps may be used in emergency situations to judge any breed. (In an emergency situation, an exhibitor does have the option of withdrawing their entry and receiving a refund.)


