ATTENTION EXHIBITORS

Dogs must be kept on leash or in crates except when competing. Please keep dogs away from livestock. Please keep all children under control and away from all farm equipment and livestock. No unauthorized persons or dogs are allowed in the barn or house.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Telephone, telegraph, faxed, incomplete or unsigned entries cannot be accepted. Entries cannot be accepted without entry fees.

Entries not on an official AKC entry form or photocopies of the entry forms without the Agreement and Rules on the reverse side of the official AKC entry form are not accepted.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian, judge or tester or barred from competition by action of the Test/Trial Committee. If because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or complete the test/trial, no refund of entry will be made. Extreme weather conditions, including, but not limited to, snow storms, hurricanes, lightning, extreme temperatures, must be considered for the health and safety of the dogs, livestock, exhibitors, judges and spectators. The well being of dogs, livestock, exhibitors and spectators is of paramount importance. In the event it is necessary to cancel or stop the test/trial before completion, no refund of entry will be made.

Returned checks do not constitute a valid entry. The secretary will add a collection fee of \$10.00 to the amount of each returned check from the same exhibitor and may result in the maker's entries being accepted on a cash only basis.

No dogs may be entered in two classes on the same course with the same kind of stock under the same judge at the trial.

Bring your crates and appropriate wear for the weather (it can rain). You will need chairs, canopies or whatever else you may wish to pack to be comfortable. Port-a-potties are available. Water is available for the dogs.
