

PUPPY SWEEPSTAKES: Dogs and Bitches between the ages of 6 months and under 12 months are eligible for the Sweepstakes. Sweepstakes entry fee is \$22.00, in addition to regular entry fee. All dogs entered in Sweepstakes must be entered in a regular class at this show.

VETERAN SWEEPSTAKES: Dogs and Bitches 7 years of age and older are eligible for the Veteran Sweepstakes. Veteran Sweepstakes entry fee is \$22.00, in addition to any other entry fee. Dogs entered in Veteran Sweepstakes need not be entered in any other class at this show.

PUPPY SWEEPSTAKES CLASSIFICATION

All Toy Breeds will be shown together in one Sweepstakes. Classes will be divided as follows:

DIVISION OF SWEEPSTAKES FUND – EACH SWEEPSTAKES

The Toy Dog Club of Puget Sound will deduct 35% from each entry to help defray a portion of Sweepstakes expenses. The remaining 65% of entry fees will be divided as follows:

Best in Sweepstakes/Veteran Sweepstakes, 6% • Best of Opposite Sex, 4%

Of the remaining 55%, the following division will be made in each class:

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For Boys and Girls who, at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN CLASS: For Boys and Girls who, at the time entries close, have won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

NOVICE & OPEN CLASS DIVIDED: **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior ID number by calling the AKC, Judges Education Department, (919) 816-3776.

BE SURE ALL INFORMATION for Junior Showmanship is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at this show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

Exhibitors should follow their veterinarians, recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

ADDITIONAL SHOW/GROUNDS RULES

The Officers and club members of TDCOPS welcome you to our Annual Toy group shows. We would like to return here every year in the future so we are asking everyone to please act responsibly and to follow a few simple rules. Anyone caught violating any of these rules could be subject to an AKC bench show hearing or a sanction from the club.

- One exercise pen allowed per grooming space in the building.
- Smoking permitted in designated areas only.
- There will be no space for unentered dogs in the Show Ring and Crating areas. Exhibitors and handlers are required to keep their grooming and parking areas clean both during and after the show. Please set a good example of responsible dog ownership to our spectators and help us retain this site for future events.
- Parents are expected to supervise their children at all times.
- Each exhibitor is responsible to pick up after his/her own dog(s).
- The Show Chairman or any club member will have the authority to maintain order on the show site, grooming area and parking lot.
- All club members will be policing the grounds and anyone found violating the rules will be reported to the Show Chairman. Violators are subject to a bench hearing.

If a dog is entered in more than one class in the show, the Recording Fee to be collected on the first entry only. (AKC Rule. Ch.11, Sec. 2). In accordance with AKC Rally regulations, the AKC will collect a \$3.00 per entry of dog Rally Event Service Fee. A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for AKC.
- CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and/or its Superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR THE COMPLETENESS OF ENTRY RESTS SOLELY WITH THE ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Superintendent will add a \$20.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- FAX ENTRIES – Fax entries will be accepted up to closing time. Fee is \$4.00 per dog per show. - ENTRIES WILL BE ACKNOWLEDGED after entries close with entry acknowledgment and judging program to address on entry. Should Exhibitor NOT receive an acknowledgment within a reasonable time, PLEASE notify the Superintendent at (360) 683-1507 or email dogshows@barayevents.com.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund of entry fee for bitches in season. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. The Superintendent will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. - Dogs need be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- Only dogs eligible for these shows will be admitted into the show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows.
