DIRECTIONS TO SITE

The "Anderson Ranch" is located just off of Interstate 75 midway between Toledo & Dayton, in Ohio, about an hour north of Interstate 70.

From Interstate 75, take Bluelick exit. Turn EAST on Bluelick Rd. (towards the gas station & motel). Once you get on Bluelick the first stop sign is at N. Dixie Hwy. The second stop sign is Cool Rd. Turn RIGHT on Cool Rd. Farm is about a quarter of a mile down and on the left way back off the road. If Bluelick dead ends you have gone about a mile past Cool Rd.

NOTICE TO EXHIBITORS

- Test/Trial location will be available from 7:00 am to 5:00 pm or one hour after conclusion of event. No unentered dogs (except set-out dogs) will be allowed at the test/trial site. All (except the club's tents) vehicles, tents, and chairs must be removed from the trial site at the end of each day. Show site is just a few miles away from a large selection of area restaurants and fast food outlets. Bitches in season will be allowed to run at the end of Test classes. Please notify the Trial Secretary if your bitch is in season.
- All American Kennel Club rules regarding conduct will be strictly enforced. No refund for duplicate entries or for any other cause beyond the control of the club after closing of entries.
- Returned checks do not constitute a valid entry. No conditional entries will be accepted. All entry forms must be signed.
- A separate entry blank for each class must be completed for each dog entered. Entries not on Official AKC entry forms and photocopies of entry forms (without the Agreement & Rules on the reverse side of the Official AKC entry form) are not acceptable.
- Owners or their agents are solely responsible for the presence of their dog(s) at the test/trial location. Judges are not required to wait for dogs. Exhibitors are expected to maintain the premises in a clean and tidy condition. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a Vet or Judge, or barred from competition by action of the Test/Trial committee. If because of riots, civil disturbances, fire, act of God, public emergency, or other acts beyond the control of the Club it is impossible to open or complete the Test/Trial, no refund of entry fees will be made.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or nijury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.
