**Dogs Eligible To Enter This Trial:** All dogs twelve months of age that have an AKC Registration Number or Indefinite Listing Privilege Number (ILP#) are eligible to participate.

**Course Familiarization and Warm-up:** Handlers in all classes will be permitted to walk the course, without a dog, prior to the start of the class. The walk-through is restricted to handlers entered only in that class. A warm-up area consisting of a regulation agility jump shall be provided for all exhibitors. There will be no obstacle familiarization period for Novice handlers at this trial.

**Classes Offered:** Novice A & B Standard, Open Standard, Excellent A & B Standard, Novice A & B Jumpers With Weaves, Open Jumpers With Weaves, Excellent A & B Jumpers With Weaves. Novice Preferred, Open Preferred, Excellent A & B Preferred, Novice Jumpers Preferred, Open Jumpers Preferred, and Excellent A & B Jumpers Preferred. No dog may participate in more than one Standard and one Jumpers with Weaves class per day. Owners may choose to enter the Preferred Standard Agility Class and Preferred Jumpers With Weaves Class in lieu of entering the Regular Standard Agility Class and the Regular Jumpers With Weaves Class at any trial. The dog must be entered only in Preferred Classes or in Regular Classes, with no crossover between them being allowed at the same set of trials.

**Jump Height Policy:** Owners are responsible for entering the proper jump height divisions. Handlers may opt to enter in a higher height division for all titling classes but not in a division lower than their proper height. Dogs may only be entered in one jump height per day for all classes. If the dog's height at the withers exceeds the maximum allowed for the jump height which the dog has entered, the dog shall be moved up into the proper jump height if the dog was measured prior to their run. In no case may a dog be moved down in height based on a judge's measurement at a trial. All dogs competing in AKC Agility must present an official AKC Jump Height Card prior to running in any classes. Please send a photocopy of your dog's jump height card with his entry to these trials. If you do not send a copy of your dog's official Height Card, you will have to present the card to the Judge prior to the start of the class or have the dog measured by the Judge.
