Seven to Ten Minutes with a volunteer judge and stewards.

Run Fee: \$7.00

Volunteer judges will be allowed one free run.

Volunteer judges and stewards accepted on day of run.

EXHIBITORS PLEASE NOTE – Animals left in vehicles will be monitored by Control Officers and Club Members. If animals are in distress due to heat or any other circumstance, the vehicle will be forcibly entered, the animal recovered and the owner cited.

USE OF RAMPS

At the sole discretion of the judge, approved breeds may be examined on the ground or on a ramp: Clumber Spaniels, Sussex Spaniels, Welsh Springer Spaniels, Basset Hounds, Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden, and Polish Lowland Sheepdogs. Whippets may be examined on the ground, on a table or on a ramp. Basset Hounds are expected to be judged on the ramp during breed judging. For the judging of Juniors, the ramp may be used at the discretion of the judge for the ramp breeds. This list may be revised from time to time, and the current list can be found on the AKC website in Judging Operations. A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required. Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or BaRay Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. **RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.**

- **ENTRIES WILL BE ACKNOWLEDGED** after entries close with entry acknowledgment and judging program to address on entry. Should Exhibitor NOT receive an acknowledgment within a reasonable time, PLEASE notify BaRay Events at (360) 683-1507 or email dogshows@barayevents.com.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for **DUPLICATE ENTRIES** or **OVERPAYMENTS**. BaRay Events will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show **NO REFUND** will be made.
