

- NOTICE TO EXHIBITORS - ALL EVENTS



The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- Effective for all events held on and after January 1, 2008, The American Kennel Club will collect a \$3.00 Event Service Fee for the first entry of a dog and a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, in all AKC licensed and member club events. The current 50 cent recording fee will continue to be collected where applicable. The event-giving club shall assume the responsibility of collecting all Event Service Fees for The American Kennel Club. These event service and recording fees shall be forwarded to The American Kennel Club along with all other required event results within seven (7) days of the close of the event.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned
 entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies
 of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray
 Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner
 or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$20.00 collection
 fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent
 may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed

- ENTRIES WILL BE ACKNOWLEDGED after entries close with entry acknowledgment and judging program
 to address on entry. Should Exhibitor NOT receive an acknowledgment within a reasonable time, PLEASE

- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the
 Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been
 entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. BaRay Events will make
 every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because
 of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or

 need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of
 their dogs in the judging rings.

USE OF RAMPS

At the sole discretion of the judge, approved breeds may be examined on the ground or on a ramp: *Boykin Spaniels, Clumber Spaniels, Field Spaniels, Sussex Spaniels, Welsh Springer Spaniels, **Basset Hounds, *Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, **Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden, and Polish Lowland Sheepdogs. *Boykin Spaniels and Whippets may be examined on the ground, on a table or on a ramp. **Basset Hounds and Bulldogs are expected to be judged on the ramp during breed judging. For the judging of Juniors, the ramp may be used at the discretion of the judge for the ramp breeds. This list may be revised from time to time, and the current list can be found on the AKC website in Judging Operations. A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required. Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)

It is certainly to our benefit as owners, breeders and exhibitors to leave behind a positive feeling with the lodging facilities and their management. Accordingly, the following rules have been established.

- 1. KEEP FLOORS CLEAN AND PROTECTED BY PLACING SHEET OR TARP UNDER ALL CRATES IN SLEEPING FACILITIES IN ORDER TO PROTECT FLOORING.
- 2. DOGS MUST NOT BE LEFT ALONE AND UNATTENDED IN HOTEL ROOMS.
- 3. DOGS MUST BE KEPT ON LEAD AT ALL TIMES IN HALLWAYS, GROUNDS AND OTHER PUBLIC AREAS OF LODGINGS. ROOMS AND GROUNDS MUST BE KEPT FREE OF DOG DEBRIS.
- 4. DOGS SHOULD BE EXERCISED IN DESIGNATED AREAS ONLY. EVERY OWNER/EXHIBITOR IS EXPECTED TO PICK UP AFTER HIS OWN DOGS AND DISPOSE OF THE WASTE IN DESIGNATED TRASH CANS.
- NO BATHING OF DOGS ALLOWED AT ANY LODGING.
- 6. ANY DAMAGES WILL BE REPORTED TO THE SHOW COMMITTEE.
- 7. NO DOGS MAY BE GROOMED IN THE STADIUM BATHROOMS AT SHOW GROUNDS.

Because of this, any owner/exhibitor will be subject to disciplinary action in accordance with the rules of the American Kennel Club, in addition to being held financially responsible for any damage to property.
