– NOTICE TO EXHIBITORS –

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- Effective for events held on and after January 1, 2004, the AKC will collect a \$1.50 AKC Event Service Fee for the first entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. The current 50 cent recording fee will continue to be collected. A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for the AKC. If a dog is entered in more than one class in the show, the Event/Recording Fees to be collected on the first entry only. (AKC Rule. Chapter 11, Section 2).
- **CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS**
- Dogs need be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side are **NOT ACCEPTABLE**. The Club and/or its Superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. **RESPONSIBILITY FOR THE COMPLETENESS OF ANY ENTRY RESTS SOLELY WITH THE ENTRANT.**
- Entry fees shall **NOT** be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund of entry fee for bitches in season. There is no refund for **DUPLICATE ENTRIES** or **OVERPAYMENTS**. The Superintendent will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show **NO REFUND** will be made.
- **RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE.** The Superintendent will add a \$20.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may result in their being put on a **CASH ONLY BASIS**.
- **REFUNDS** for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent **AFTER THE SHOW**. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Only dogs eligible for this show will be admitted into the show area. There is no provision for unentered dogs.
- The judging will start promptly. Dogs may arrive anytime prior to their time of judging, and may leave immediately thereafter, unless required for further judging.
- **ENTRIES WILL BE ACKNOWLEDGED** after entries close with entry acknowledgment and judging program to address on entry. Should Exhibitor **NOT** receive an acknowledgment within a reasonable time, **PLEASE** notify the Superintendent at (360) 683-1507 or email dogshows@barayevents.com.
- **LOSS OR DAMAGE** – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. BEST OF BREED COMPETITION: The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and dogs that according to their owners records have completed the requirements for a Championship but whose Championships are unconfirmed. The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owner's records.

Non-Regular Classes (involving multiple dog entries)

STUD DOG CLASS: For Stud Dogs and two, or not more than three, of their Get. (Get limit will be enforced.) Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. The owner of the Stud Dog need not necessarily be owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard for its Breed. Get must be entered in a regular class, Best of Breed competition or some other non-regular class.

BROOD BITCH CLASS: For Brood Bitches and two, or not more than three, of their Produce. Same rules as Stud Dog.

BRACE CLASS: For two Labrador Retrievers of IDENTICAL ownership. Dogs entered in the Brace Class must be entered in a regular or non-regular class at this show. If more than one Brace is entered by the same owner, the dogs comprising each Brace must be designated "Brace No.1," "Brace No.2"

SPECIAL ATTRACTION CLASSES

For dogs and bitches that have earned a title in 3 different performance categories. WC, GGC, CC Not Included. Winning one of these classes does NOT make a dog eligible for Winners or Best of Breed Classes.

PUPPY SWEEPSTAKES

To stimulate interest in the showing of promising Labrador Retrievers, a Sweepstakes will be held in conjunction with the Puget Sound Labrador Retriever Association's specialty show.

1. Labrador Retrievers 6 months and under 18 months are eligible.
2. Dogs who are Champions by Owner's or AKC records may not compete.
3. Professional handlers may handle only their own dogs.
4. **DOGS ENTERED IN THESE CLASSES MUST BE ENTERED IN A REGULAR CLASS.**
5. Specific Sweepstakes Classes must be given on entry blanks in space marked "Additional Classes," state class, as Sweepstakes Dog or Bitch and proper age classification.
6. Entry fee due with regular fee - \$16.00.
7. If dog becomes ineligible after close of entries, dog must be withdrawn. Entry fee will not be refunded.
