

## ***NOTICE TO EXHIBITORS***

**The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.**

- Effective for all events held on and after January 1, 2008, The American Kennel Club will collect a \$3.00 Event Service Fee for the first entry of a dog and a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, in all AKC licensed and member club events. The current 50 cent recording fee will continue to be collected where applicable. The event-giving club shall assume the responsibility of collecting all Event Service Fees for The American Kennel Club. These event service and recording fees shall be forwarded to The American Kennel Club along with all other required event results within seven (7) days of the close of the event.
- CANADIAN CHECKS OR MONEY ORDERS MUST BE DRAWN ON U.S. ACCOUNTS, AND/OR MADE PAYABLE IN U.S. FUNDS
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$20.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries. There is no refund for bitches in season in Obedience.
- FAX ENTRIES – Fax entries will be accepted up to closing time. Fee is \$4.00 per dog per show. If the credit card charge is denied for any reason, an additional service charge of \$20.00 will be added. FAX NUMBER: (360) 683-6654. This is for Fax Machine ONLY. Incomplete or illegible Fax entries are not acceptable as a valid entry in a show. Proof of transmission is not proof of receipt of a legible or complete transmission (under AKC Rule Ch. 11, Sec. 4). - ENTRIES WILL BE ACKNOWLEDGED after entries close with entry acknowledgment and judging program to address on entry. Should Exhibitor NOT receive an acknowledgment within a reasonable time, PLEASE notify BaRay Events at (360) 683-1507 or email [dogshows@barayevents.com](mailto:dogshows@barayevents.com).
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. BaRay Events will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor its Superintendent/Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- Only dogs eligible for these shows will be admitted into the show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- TROPHIES & PRIZES will be awarded in the ring to person exhibiting the dog. No awards will be mailed.
- ALL RIGHTS TO TELEVISION, VIDEOTAPE, ADVERTISE, PHOTOGRAPH, PROMOTE or otherwise exploit this event are vested in the Club, or in persons to whom assignments of such rights have been made in writing by the Club. **Coursing Dog Class      Coursing Bitch Class**

For AKC registered Dogs & Bitches with confirmed Lure Coursing or Open Field Titles. Titles may be earned from any recognized coursing organization. *NOTE: Exhibitor MUST supply proof of eligibility for class with entry. A copy of the certificate awarding the title or a copy of the ENTIRE*

PAGE from either the AKC Awards or FAN magazine publishing the title will be accepted as proof. Spayed & Neutered Salukis may be entered in Coursing Classes. First Place winners are eligible for Best of Breed Competition provided all AKC eligibility & requirements have been met.

#### BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed Competition: dogs that are Champions of Record and dogs according to their owners' records have completed the requirements for a Championship but whose Championships are unconfirmed. The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owners' records.

#### SELECT DOG & SELECT BITCH

AWARD OF MERIT: Two (2) awards will be offered for dogs of merit excluding the dogs awarded BOB, BOS, or BOW.

BEST PUPPY FROM THE REGULAR PUPPY CLASSES

BEST FROM THE BRED BY EXHIBITOR CLASSES

BEST FROM THE VETERANS CLASSES

#### Non-Regular Classes (Involving multiple dog entries)

**STUD DOG CLASS:** For Stud Dog and at least two of his Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. The owner of the Stud Dog need not necessarily be owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in a Regular Class, Best of Breed competition, or some other non-regular class. Get must be entered in one of the regular classes.

**BROOD BITCH CLASS:** For Brood Bitch and at least two of her Produce. Brood Bitch must be entered in the Brood Bitch Class and must be shown in the ring with their Produce. The owner of the Brood Bitch need not necessarily be owner of the Produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Produce must be entered in a Regular Class, Best of Breed competition, or some other non-regular class. Produce must be entered in one of the regular classes.

**BRACE CLASS:** Two dogs that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. The Dogs comprising a Brace MUST be named at the time of entry. In making entries for "Brace Class Only" full particulars MUST be given for each dog on individual entry forms. ***Brace entries MUST be submitted together in the same mail, fax, or online session.***

*NOTE: As the judge's decision in the Stud Dog, Brood Bitch, or Brace Class is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.*

**Extended Generation Class:** Entry to be made up of a minimum of three generations of Salukis, with one descendant from each successive generation, i.e. Dogs A,B,C where A is sire/dam of B who is sire/dam of C. Only one representative from each generation is allowed.

**Parade of Title Holders. Prior to Regular Judging, following Sweepstakes Classes,** there will be a non-competitive Parade of AKC Title Holders Any AKC Champion of record or AKC Title Holder is eligible for the Parade. The entry blank must have PARADE written in the space for "other Classes". **Please fill out enclosed Parade of Title Holders form enclosed and send with your completed entry.**

**EXHIBITORS PLEASE NOTE Animals left in vehicles will be monitored. If animals are in distress due to heat or any other circumstance, the vehicle will be forcibly entered, the animal recovered and the owner cited.**

## ***SWEEPSTAKES & VETERAN SWEEPSTAKES – EACH DAY***

### **SWEEPSTAKES REQUIREMENTS**

All Sweepstakes dogs and bitches must also be entered in a Regular or Non-Regular Class of the Specialty Show on the same day, at the appropriate fee and on the SAME entry form, marked "Sweepstakes (age division)" in the Additional Classes box.

### **SWEEPSTAKES CLASSIFICATION**

*The following classes will be offered for both dogs & bitches.*

- Puppy, 6 months & under 9 months
- Puppy, 9 months & under 12 months
- Junior, 12 months & under 18 months
- Junior, 18 months & under 24 months

### **VETERAN SWEEPSTAKES REQUIREMENTS**

Open to dogs and bitches 7 years of age and older. Veteran Sweepstakes dogs and bitches need not be entered in any other class at the Specialty Show.

### **VETERAN SWEEPSTAKES CLASSIFICATION**

*The following classes will be offered for both dogs & bitches*

- Veteran Dogs & Veteran Bitches (7 years & under 10 years)
- Veteran Dogs & Veteran Bitches (10 years & older)

### **PRIZE MONEY – SWEEPSTAKES & VETERAN SWEEPSTAKES**

Prize money will be calculated on the total of entry fees received. 25% of the total money will be retained by the club for expenses. 15% will be awarded for Best in Sweepstakes/Veteran Sweepstakes. 10% will be awarded for Best of Opposite Sex in Sweepstakes/Veteran Sweepstakes, and the remaining 50% will be divided into a stake for each class by the ratio of the number of dogs actually entered in each class. The stakes for each class will then be divided as follows:
