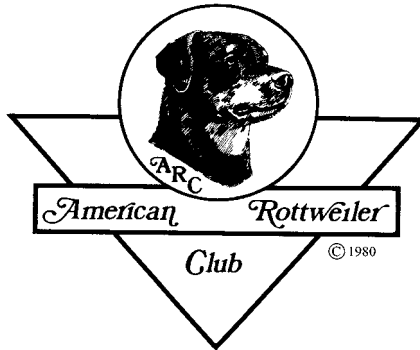

ATTENTION EXHIBITORS

Welcome to the 2012 ARC National Specialty. The show site will be available to Exhibitors at 1:00PM, Tuesday May 22, 2012 and at 7:00 am Wednesday thru Saturday. No dogs are allowed overnight and must be removed no later 7PM each night. All dogs/crates must be removed from the Event Center by 5PM Saturday May 26, 2012. There will be plenty of space for spectators and holding area for dogs waiting to go into the ring. No un-entered dogs are allowed in the Exhibitor Center.

Conformation Crating: There will be no ringside crating outside the Conformation Ring. Day crating will be available in the Grooming Room on a "first-come/first-served" each day; however, all crates must be removed immediately after showing and there will be no electricity available. Reserved crating inside the grooming room is available by reservation only and must be pre-paid. See Reserved Inside Grooming on page 10.

Agility, Obedience & Rally Crating: Ringside crating will be allowed outside the Agility and Obedience/Rally Rings for dogs participating in those venues only. Crates in Performance area must have something placed under them: plastic, mat, etc.

No cones/ taping/etc. is allowed in the Exhibition Hall as well as in any parking area at Purina and ALL Hotels. There are no ex pens allowed in the Purina Parking Lot; nor is there any overnight parking. Violators may be subject to an Event Committee Hearing.

Exhibitors are responsible for keeping their dogs under control at all times & **MUST** clean up after their dogs in any area of Purina Farms. Remember that dogs need to be on leash at all times. The Dog/Bitch must have earned one or more of the following AKC titles: CD; RN; TD; HS; NA; NAJ; NAP; NJP; NF; NFP; or an American Rottweiler Club CS. A Dog/Bitch is also eligible if it has earned one of the following titles: SchH A; SchH I; IPO I; VPG I; FH; BH; AD. Copy of title and/or Scorebook must be included with entry. Spayed and Neutered animals are ineligible to be entered in this class. Champions of Record are eligible to enter.

Winners of the above Non-Regular Single Dog classes, if otherwise undefeated,
are eligible to compete for Best of Breed.

BEST PUPPY FROM THE REGULAR PUPPY CLASSES AND BEST FROM THE BRED BY EXHIBITOR CLASSES: Winners of Best Puppy or Best Bred by Exhibitor are not, by right of winning this award, eligible to compete for Best of Breed.

BEST OF BREED COMPETITION: The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and dogs that according to their owners records have completed the requirements for a Championship but whose Championships are unconfirmed. The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owner's records. AKC Select Dog and Bitch and ARC Selects will be awarded following Best of Breed.

ARC SELECT AWARDS: All dogs eligible for the Best of Breed Competition shall be considered for these awards. At the discretion of the intersex judge, the maximum number of Select Awards that may be given shall be 10% of the Best of Breed entry, including Veterans, Winners and Working Dog/Bitch. That 10%, with no consideration to sex, is in addition to the ones automatically given

Best of Breed and Best of Opposite Sex to Best of Breed winners and the AKC Grand Championship Select Dog and Bitch (if awarded). The Best of Breed and Best of Opposite Sex to Best of Breed shall be known as ARC Select 1; the AKC Grand Championship Select Dog and Bitch shall be known as ARC Select 2; all others chosen shall be known simply as Select.

Non-Regular Classes Involving Multiple Dog Entries

As the judges decision in the Stud Dog and Brood Bitch Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible for Best of Breed Competition by virtue of having won any of these classes.

STUD DOG CLASS – For Stud Dogs and two their Get. Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with their get. The owner of the stud dog need not necessarily be owner of the get. While the merits of the stud dog are not to be considered in the placement of the entry, the stud dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard of the breed. Get must be entered in a regular class, Best of Breed Competition, or some other Non-Regular class. An entry fee of \$35.00 will be charged for the Stud Dog if he is NOT entered in one of the Regular Classes, Non-Regular Classes or for Best of Breed Competition. Entry fee for Stud Dog as an additional class is \$25.00.

THE FUTURITY IS OPEN ONLY TO BREEDERS WHO ARE MEMBERS OF THE AMERICAN ROTTWEILER CLUB AND IN GOOD STANDING AT THE TIME OF THE LITTER NOMINATION. CO-BREEDER DOES NOT HAVE TO BE AN ARC MEMBER, BUT MUST BE IN GOOD STANDING WITH THE AMERICAN KENNEL CLUB. BOTH PARENTS OF THE LITTER MUST MEET ALL THE REQUIREMENTS OF THE ARC MANDATORY PRACTICES FOR BREEDING. Any breeder of a nominated litter who fails to remain in good standing with the ARC or AKC and has not been reinstated 60 days prior to the Futurity shall lose all rights in the ARC Futurity. There will be no refunds of any nomination fees - litter or puppy. The Futurity is entered by nominating the litter. The get from this litter are eligible to compete in the first annual Futurity held on or after the date they reach 6 months of age, and only in this Futurity. The Futurity is open to all Rottweilers who were born between 11/12/10 and 11/22/11, provided both the litter and the individual puppy have been properly and timely nominated.

* The dates of the ARC National Specialty fluctuate from year to year, so there will be times when puppies 18 months and older will be entered because they were NOT 6 months old when the prior year's Futurity was held. The 2011 Futurity was held on May 11th, so dogs born between 11/12/10 and 11/22/10 are eligible to compete even though they are older than 18 months of age.

The puppy MUST be entered in 1 of the regular classes at the ARC National Specialty show and entry fee paid. Futurity entry MUST BE INDICATED AS AN ADDITIONAL CLASS on the entry form (no additional fee is required). Additional class entry must include age division (e.g., futurity 6-9 months).

No Rottweiler will be eligible to compete in the Futurity, which does not meet the following requirements:

1. Be from a litter that was properly and timely nominated, or have met the requirements for late nomination.
2. Have been individually nominated before it reached the age of 4 months, or have met the requirements for late nomination.
3. Be properly entered in 1 of the regular classes of the ARC National Specialty.

4. Both parents of the litter must meet all the requirements of the ARC Mandatory Practices for breeding

FUTURITY PRIZES

In this stake there will be 43 cash wins, the three individuals (the breeder, the owner, and the owner of the sire at the time of nomination) partaking of these awards, for a total of 88 monetary awards, won by 40 different Rottweilers.

Twenty percent shall be deducted from the total nomination fee purse to be used for Futurity expenses. This will be known as the General Expense Fund. This Fund shall be used to cover all expenses incurred by the Futurity, i.e., judges, rosettes, Chair expenses, etc. Since the administrative and judging expense will vary from year to year, excess in any given year shall be carried for use in future years.

Twenty percent shall be deducted from the total nomination and entry fee purse to be awarded as follows: 10% to the Best in Futurity, 5% to the Best Senior in Futurity, and 5% to the Best Junior in Futurity. The 10% Best in Futurity award will be divided: 50% to the recorded breeder of the winner and 50% to the recorded owner of the winner. The 5% awarded to the Best Junior and Best Senior in Futurity is to be divided: 50% to the recorded breeder, 30% to the recorded owner and 20% to the owner of the sire or owner of the frozen semen at the time of mating, for each winner.

The remaining 60 percent of the total nomination fee purse shall be divided by the total number of puppies entered to get a "per puppy amount". This amount would be multiplied by the number of puppies in each class to get the total amount of prize money for that class and then each class shall be divided as follows: 1st place: 40%*; 2nd place: 30%*; 3rd place: 20%*; 4th place: 10%*. *The prize money for each placement shall be further divided with the 60% to the recorded breeder; 40% to the recorded owner.

Monetary Awards will be given to the handler presenting the puppy in the ring for the four class placements. The Best Junior, Best Senior and Best in Futurity monetary awards will be given to the breeder who nominated the litter, the sire's owner who is listed first on the litter nomination and the puppy owner who is listed first on the individual puppy nomination. The monetary award will be mailed to them should they not be present.

Monetary awards, which are provided for but cannot be given, whatever the reason, shall be sent to the ARC Treasurer and incorporated into the ARC General Fund.

The Best in Futurity Trophy will be given to the breeder who has nominated the litter. Should the winner not be present the trophy will be mailed.

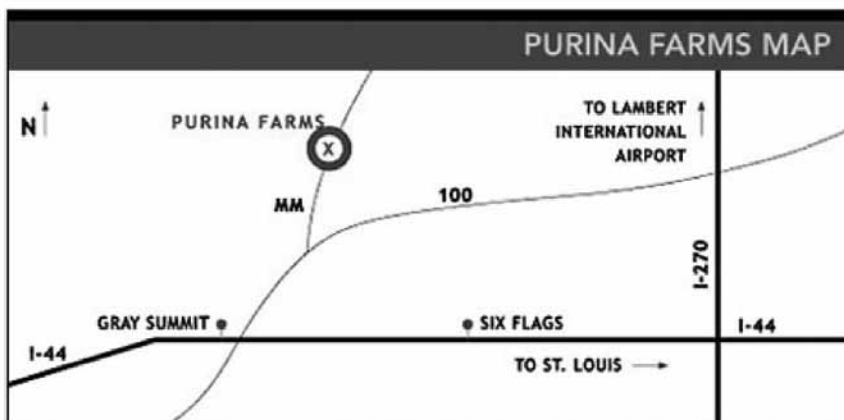
