### **THE GAYLA GARDNER MEMORIAL BEST PUPPY COMPETITION – SATURDAY ONLY**

**This event is held through the generosity of the estate of Gayla Gardner**

Best Puppy will be awarded from the First Place winners in the Regular Puppy Classes (6-9 mos. & 9-12 mos. ONLY) immediately following each breed. If the Best of Breed is awarded to a dog/bitch coming from one of the Puppy Classes for that breed, the Best Puppy win is automatic. Best Puppy Group will be judged following the Variety Group that included that breed in a nearby ring. First through Fourth Place in each Group will be awarded, with the Group Winner going on to Best Puppy in Show. If the dog/bitch judged First in their respective regular group was also the Best Puppy for their breed, first place in the Puppy Group is automatic, and judging will be for second through fourth places only. Judges for Best Puppy in Breed, Puppy Group, and Best Puppy in Show will be as published for the regular classes. Best Puppy in Show will be judged immediately before regular Best in Show competition.

### **VETERAN GROUP AND BEST IN SHOW SHOWCASE COMPETITION – SUNDAY ONLY**

The Tanana Valley Kennel Club, Inc. will hold Veterans Group and Best Veteran in Show Showcase Competition on Sunday, May 27, 2012 in conjunction with our regular all-breed show competition. Two competitions will be offered: **Dogs 7 Yrs. & Under 10 Yrs. Old**, and **Dogs 10 Yrs. Old and Older**.

To compete in the Age Class Competitions, dogs must meet the age criteria on the day of the show. For the 7-10 Years Old, **Dog must be at least 7 years, but less than 10 years** on the day of competition. For the 10 Years Old and Older class, **Dog must be at least 10 years** on the day of competition.

It is the owner or agent's responsibility to ensure dogs are entered in the correct age class. Dogs not meeting the age class criteria will be disqualified from competition. No refunds will be allowed for dogs entered in the wrong age class.

**Entry fee is \$17.00.**

This AKC-approved special event allows Veterans in all AKC approved breeds to compete for Best Veteran in Group 7 up to 10, and Group 10 and older, and Best in Show Veteran 7 up to 10, and Best in Show Veteran 10 and older.

***There will be no Breed-level Veteran Classes.*** Altered dogs and bitches are eligible to compete. Entries will be divided by Group and Age Class levels only. All dogs entered will be assigned to their respective Veteran Group and Age Class, and will enter the Group Ring together. Judging will be for placement as first, second, third, and fourth in each group. The Group Winners from each Age Class will compete for Best Veteran in Show by Age Class, immediately before regular Best in Show competition.

### **USE OF RAMPS**

At the sole discretion of the judge, approved breeds may be examined on the ground or on a ramp: \*Boykin Spaniels, Clumber Spaniels, Field Spaniels, Sussex Spaniels, Welsh Springer Spaniels, \*\*Basset Hounds, \*Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, \*\*Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden, and Polish Lowland Sheepdogs. *\*Boykin Spaniels and Whippets may be examined on the ground, on a table or on a ramp. \*\*Basset Hounds and Bulldogs are expected to be judged on the ramp during breed judging.* For the judging of Juniors, the ramp may be used at the discretion of the judge for the ramp breeds. This list may be revised from time to time, and the current list can be found on the AKC website in Judging Operations. A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required. Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)

Dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owners' records. If at the end of the 90 day period the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC." Selects, if applicable, will be chosen following Best of Breed.

**\*Obedience Team Class.** The Team class will be for teams of any four dogs that are eligible under these regulations. Five dogs may be entered, one to be considered an alternate for which no entry fee will be required. However, the same four dogs will perform all exercises. Dogs may be handled by the owner or any other person, need not be entered in another class at the same trial, and need not have obedience titles. A separate official entry form will be completed in full for each dog entered. No dog may be entered on more than one team. The dogs on a team will perform the exercises simultaneously and will be judged as specified for the Novice class, except that a Drop on Recall will be used in place of the Recall exercise.

**\*\*Rally Team Novice Competition.** Teams will consist of four handlers with a total possible score of 400 points for each team. All team members will run the course individually, with the team time running continuously. Time will start when the judge gives the first member of the team the forward command from the "Start" sign. The subsequent dog for each team starts when the previous handler for the team passes the "Finish" sign without an additional command of "Forward" by the judge. Timing for each team will begin when the judge commands the first handler in the team to begin with the command "Forward" and will stop when the fourth handler for the team passes the finish line.

**BITCHES IN SEASON IN OBEDIENCE AND RALLY** – Owner of a bitch who goes into season after the show closes, will receive a refund of 50% of that bitch's entry fee. A written statement from owner must be presented to the superintendent thirty minutes prior to the opening of the show/trial.

**VERSATILE VETERANS CLASS (SATURDAY ONLY)**– The Versatile Veterans Class shall be for dogs that are at least seven (7) years of age. The dog may NOT compete in this class if it is also entered in the regular open or utility classes. A person may enter more than one dog in this class. There will be no group exercises in this class. Dogs entered in this class are to jump at the multiple of 2 nearest to half of the dog's height at the withers. All dogs must perform the Signal Exercise as described in the regular utility class OR the heel free and figure 8 exercise as described in the regular open class (25 points). Seven exercises from the Open and Utility regular classes (Drop on Recall, Retrieve on the Flat, Retrieve over the High Jump, Moving Stand, Scent Discrimination, Directed Retrieve, Directed Jumping) are available. The dog must perform five of the seven exercises, with the handler indicating which exercises will be excluded at the time that the armband is picked up during check-in. The open/utility exercises will be performed as in the regular classes, with each exercise being worth 35 points. Total points for the class will be 200.

**NOVICE CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.
