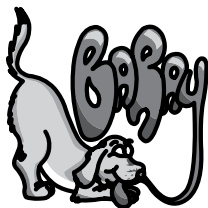

A Class for Dogs and a class for Bitches that have a Working Certificate (WC), Working Certificate Intermediate (WCI) or Working Certificate Excellent (WCX) from the NSDTRC (USA) or an AKC Junior Hunter title (JH), Senior Hunter title (SH) or Master Hunter title (MH).

Winners of the above non-regular classes, if otherwise undefeated, will compete for Best of Breed.

BEST OF BREED COMPETITION

Select Dog, Select Bitch, Awards of Merit

Followed by

BEST PUPPY FROM THE REGULAR PUPPY CLASSES: To be selected from the first place winners in the Puppy Classes (6-9 mos. & 9-12 mos.)

BEST VETERAN FROM THE VETERANS CLASSES: To be selected from the first place winners of all the Veteran Classes.

BEST BRED-BY-EXHIBITOR COMPETITION: To be selected from the first place winners of the Bred-By-Exhibitor Classes.

BEST HUNTING RETRIEVER COMPETITION: To be selected from the first place winners of all the Hunting Retriever Classes.

Non-Regular Classes (Involving Multiple Dog Entries) (Following Best of Breed)

STUD DOG CLASS: For Stud Dogs and two of their Get. Stud dog must be entered in the Stud Dog Class and shown in the ring with their Get. Owner of the Stud Dog need not necessarily be the owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in a regular class, Best of Breed, or some other non-regular class.

BROOD BITCH CLASS: For Brood Bitches and two of their Produce. Brood Bitch must be entered in the Brood Bitch Class and shown in the ring with their Produce. Owner of the Brood Bitch need not necessarily be the owner of the Produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Produce must be entered in a regular class, Best of Breed, or some other non-regular class.

NOTE: *As the judge's decision in the Stud Dog and Brood Bitch Class is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in this class will be eligible to compete for Best of Breed by virtue of having won this class.*

Awards of Merit will be awarded after Best of Breed judging is completed to Nova Scotia Duck Tolling Retrievers in Best of Breed competition that exemplifies the breed's characteristics. These awards are reserved for those quality animals the judge feels are worthy of final consideration for Best of Breed. The dogs selected for Best of Breed and Best of Opposite Sex to Best of Breed are not eligible for an Award of Merit. At judges discretion, up to three (3) awards will be awarded in the Best of Breed competition, which shall include move-ups, Winners Dog, Winners Bitch, first place in Veteran Dog Classes, and Veteran Bitch Classes, first place in Hunting Dog and Hunting Bitch.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

CHALLENGE TROPHIES

Best Puppy Perpetual Trophy: This is a bronze sculpture of a retriever playing in the water. Sagewood Kennel Best Puppy in Specialty Show Trophy offered by Patty and Paul Beran through the Nova Scotia Duck Tolling Retriever Club (USA). This trophy is offered on a three time win basis, with permanent possession of the trophy going to any person/owner who wins the trophy three separate times, not necessarily with the same dog.

Best Veteran Perpetual Trophy: This is an etched crystal of a toller coming out of the water with a duck. Hoch Memorial Trophy offered by Dee Nichols (KD's Kennel) and Laura White (Cinnstar Kennels) in memory of Robert Hoch through the NSDTRC (USA). This trophy is offered on a three-time win basis, with permanent possession of the trophy going to any person/owner who wins the trophy three separate times, not necessarily with the same dog

High in Trial Perpetual Trophy: A silver cup trophy on a base. Lonetree Kennel High in Trial Trophy offered by Lonetree Kennels through the NSDTRC (USA). This trophy is offered on a three-time win basis, with permanent possession of the trophy going to any person/owner who wins the trophy three times, not necessarily with the same dog.
