DOGS ELIGIBLE TO ENTER

Monday – Open to all AKC recognized Breeds and dogs enrolled in the Canine Partners Program Tuesday – Open to Belgian Tervuren ONLY.

Dogs must be 15 months of age and older that are registered with the American Kennel Club. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes.

MEASURING and HEIGHT CARD INFORMATION

All agility dogs are required to have an Official Jump Height Card and exhibitors must be able to present it prior to running their dog(s) in any class or at any time during the trial upon request. Dogs without a valid Jump Height Card may still compete, but they must be measured by the Judge of Record PRIOR to running in their class and this measurement will be valid for this trial or back-to-back trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a Volunteer Measuring Official (VMO) or an Agility Field Rep is present; ALL dogs without a valid Jump Height Card must be measured at some time during the trial or cluster of trials. This does not preclude having the dog measured by the Judge of Record if the VMO or Rep is not available to measure the dog before its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

OBSTACLES

Obstacles will meet the specifications for obstacles in the current edition of the A.K.C. Regulations for Agility Trials

HANDLER WALK-THROUGH, TIMING AND WARM UP

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent. A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog. Electronic timing devices will be used.

CRATING / FOOD

There is plenty of room for crating around the rings. Please bring chairs, crates, and clean up tools for your dogs. The trial site will be available for set up on Monday, May 27th, starting at 10 am. NO setups are permitted prior to this time due to another event that is using the facility on Sunday. The trial committee and club reserves the right to move set-ups, without notice, if space if needed for trial administration use.

There will be a food vendor at these trials. Other restaurants are in easy driving distance.

INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and <u>may not</u> compete in a jump height division <u>higher or lower</u> than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
