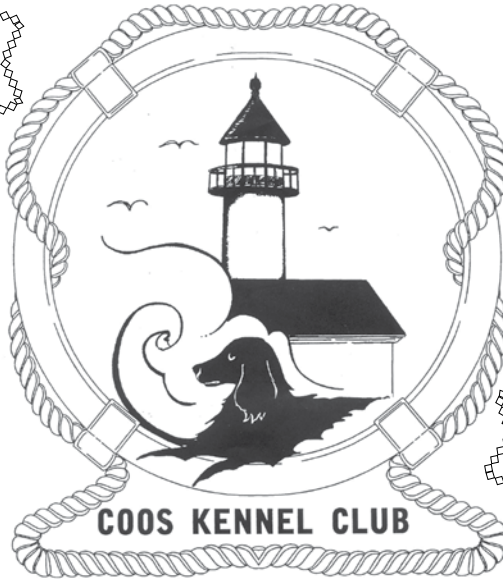

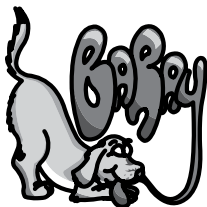

## **BREEDS WITH OPEN CLASS DIVISIONS AT THESE SHOWS – BOTH SEXES**

### **OPEN CLASS DIVISION MUST BE INDICATED ON ENTRY BLANK**

**Retrievers (Labrador):** Black; Chocolate; Yellow.

**Dachshunds (All Varieties):** Miniature (under 11 lbs. & 12 mos. old or over); Standard (11 lbs. & over and under 11 lbs. If less than 12 mos. old).

**Boxers:** Brindle; Fawn.

**Dobberman Pinschers:** Black; Any Other Allowed Color.

**Great Danes:** Black; Blue; Brindle; Fawn; Harlequin; Mantle.

**Pugs:** Black; Fawn.

**Boston Terriers:** Under 15 lbs.; 15 lbs. & over

**Australian Shepherds:** Black; Blue Merle; Red Merle; Red.

**Collies (Rough):** Blue Merle; Sable & White; Tri-Color; White.

**Shetland Sheepdogs:** Sable & White; Any Other Allowed Color.

### **DIRECTIONS TO SHOW SITE – Bandon High School, 550 9th St. SW, Bandon, OR.**

**From the North:** Drive North on Hwy I-5 to Hwy. 38 (Drain/Elkton), exit 162. Follow Hwy 38 to Reedsport where Hwy 38 runs into Hwy 101. Turn left and follow Hwy 101 to Bandon. Turn right onto 9th St. SW. Destination is on the right.

**From the South:** Follow I-5 to exit 119 (Coos Bay/Oregon coast). Continue on to Winston, turn right at 4 way stop light onto Hwy 42 W.. Follow Hwy 42 for about 70 miles. In Coquille turn left about 1/4 mile past the 4 way stop light onto Hwy 42S. Follow Hwy 42S for about 17 miles. Turn left onto Hwy 101 and 2nd street. Continue on Hwy 101 for about 1 mile, turn right onto 9th st. Destination on right.

### **USE OF RAMPS**

At the sole discretion of the judge, approved breeds may be examined on the ground or on a ramp: \*Boykin Spaniels, Clumber Spaniels, Field Spaniels, Sussex Spaniels, Welsh Springer Spaniels, \*\*Basset Hounds, \*Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, \*\*Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden, and Polish Lowland Sheepdogs. *\*Boykin Spaniels and Whippets may be examined on the ground, on a table or on a ramp. \*\*Basset Hounds and Bulldogs are expected to be judged on the ramp during breed judging.* For the judging of Juniors, the ramp may be used at the discretion of the judge for the ramp breeds. This list may be revised from time to time, and the current list can be found on the AKC website in Judging Operations. A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required. Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)
