### **Non-Regular Classes Involving Single Dog Entries**

Veteran Dog Class, 7 yrs. & under 10 yrs. ....Veteran Dog Class, 10 yrs. & under 13 yrs.

Veteran Dog Class, 13 yrs. & older .....Same classes for bitches

Field Trial Dog/Bitch Classes: This class is open only to those dogs that have received a title in AKC field trials. Dogs with a JC title only are not eligible. Entries may not be spayed or neutered.

Bred by Exhibitor (BBE) Class Eligibility

- All dogs entered in the Bred by Exhibitor Class must be individually registered with the AKC.
- The person handling the dog must be a breeder of record of the dog and an owner of record of the dog.
- To exhibit in this class, family members must be a breeder and owner of record.

### **BEST BRED-BY-EXHIBITOR COMPETITION**

**RULES:** During the course of regular judging, the assigned judge will select a Best Bred By Exhibitor from the Bred-By-Exhibitor class winners. This will be done after the Best of Breed/Variety Competition unless the Best Bred-By-Exhibitor award is automatic. Example: An entry from the Bred-By-Exhibitor class is awarded Best of Winners or Best of Breed. Only dogs and bitches undefeated in a Bred-By-Exhibitor class are eligible for the Best Bred-By-Exhibitor Competition. If the first place winner is not present, the second place winner may not compete. NO ADDITIONAL FEE IS REQUIRED.

### **NON-REGULAR CLASSES (INVOLVING MULTIPLE DOG ENTRIES)**

*Note: As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won the class. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."*

**Stud Dog Class:** For Stud Dogs and two of their Get. Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with their get. The owner of the stud dog need not necessarily be owner of the get. While the merits of the stud dog are not to be considered in the placement of the entry, the stud dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard of the breed. Get must be entered in a regular class, Best of Breed Competition, or some other Non-Regular class. The Stud Dog shall be considered one entry and requires one entry fee.

**Brood Bitch Class:** Same as for Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

**Brace Class:** Two dogs, performing in unison, and presented by a maximum of two handlers. Both

dogs competing in the brace class must have at least one common owner. At least one dog must be entered in another class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class." If more than one Brace is entered by same owner, dogs comprising EACH BRACE must be designated "Brace No. 1," "Brace No. 2," etc. Fee for this class is \$25.00 as a Unit.

**SPECIAL NOTE:** New for BCOA 2013! As adopted on September 11, 2012, by the AKC Delegate Body – per AKC rules applying to dog shows, Chapter 16, Section 1: "At the National Specialty, the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a 3 point major, provided that the number of dogs competing in the regular classes of the Reserve Winners' sex totals at least twice the number required for a 5 point major, in the region in which the event is held. No major for Reserve Winners shall be given based on an award of Best of Winners. In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld, shall not be included."

According to the 2013 point schedule for Division 8 (Washington State's division), the floor of a five-point major in dogs is 21; therefore, a minimum number of 42 eligible class dogs must be in competition for RWD to be awarded a 3 point major. The floor of a five point major in bitches is 25; therefore, a minimum number of 50 eligible class bitches must be in competition for RWB to be awarded a 3 point major.

### ***JUNIOR SHOWMANSHIP***

---

**NOVICE CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

**MASTER CLASS:** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 – October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

**NOVICE AND OPEN CLASS DIVIDED:** Junior – 9 years old and under 12 years old on the day of the show; Intermediate -12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

NOTE: Junior Handlers must include their AKC Junior Handler Number on each entry. Junior Handler Identification Number may be obtained by calling the AKC Judges Department at (919) 233 – 9767. **NOTE: Juniors with a dog also entered in another class offered at this show who substitute a dog not entered in this show must remit the difference between Junior only and Junior as an additional class entry fee. Juniors who have entered Junior Showmanship only, who then substitute another dog, will not be charged a further fee.**

Qualifying scores will not be required for awarding of ribbons and prizes in the Non Regular Classes.

The Veterans class will be for dogs that have an obedience title and are at least 7 years old on the date of the trial.

**RALLY NON REGULAR CLASSES** – Rally Pairs, Novice • Rally Relay

**Rally Relay:** This BCOA defined Non-Regular class will be for teams of any 3 dogs and handlers that are eligible under AKC Regulations. Four dogs may be entered, one to be considered an alternate for which no entry fee will be required. A separate official entry form must be completed for each dog, including the alternate dog if one is listed. The owner or any other person may handle dogs in this class. All exercises are performed on leash. The Rally Relay course will be created from the Rally Novice exercises and will consist of 15 or 16 stations. The members of the team will wait near their assigned stations for the pass of the baton. The first dog and handler team performs the first five stations on the course while carrying a small baton. The second dog and handler team performs the 5th station in tandem with the first team as the baton is passed, and the second team then performs stations 6 through 10. The third team performs the 10th station in tandem with the second team as the baton is passed, and the third team then performs the rest of the stations, finishing the course. This class will be judged and scored as in the Rally Novice class. If both dog and handler teams have an error on the exercise where a baton is passed, both errors would be scored. In the event of a tie for placements, time will be used as a tiebreaker. Qualifying scores will not be required for awarding of ribbons and prizes.”

## **VETERAN SWEEPSTAKES**

The Veteran Sweepstakes is open to all Basenjis 7 years of age or older on the day of the show. Spayed bitches or neutered dogs are eligible. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- Only dogs eligible for these shows will be admitted into the show area. There is no provision for unentered dogs.
- **LOSS OR DAMAGE** – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
