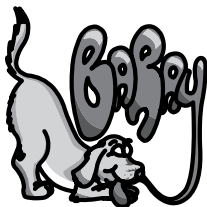

Open to any English Springer Spaniel which has earned the Parent Club Working Certificate or the Working Certificate Excellent or achieved one Qualifying Score at an AKC Licensed Spaniel Hunting Test. Judging will be on conformation only.

BEST OF BREED COMPETITION: The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of record and dogs according to their owner's records have completed the requirements for a Ch. but whose Ch. is unconfirmed. Showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owners' records.

Non-Regular Classes (involving multiple dog entries)

STUD DOG CLASS: For Stud Dogs and two of their get. Stud Dogs **MUST** be entered in the Stud Dog Class and must be shown in the ring with their Get. The owner of the Stud Dog need not necessarily be the owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require it disqualification or excusal under the Dog Show Rules, AKC policy or the standard for its breed. Get must be entered in a regular class, Best of Breed competition, or some other non-regular class.

BROOD BITCH CLASS: For Brood Bitches and two of their Produce. Brood Bitches **MUST** be entered in the Brood Bitch Class and must be shown in the ring with their Produce. The owner of the Brood Bitch need not necessarily be the owner of the Produce. While the merits of the Brood Bitches are not to be considered in the placement of the entry, the Brood Bitches must be examined to determine if it has a condition that would require it disqualification or excusal under the Dog Show Rules, AKC policy or the standard for its breed. Produce must be entered in a regular class, Best of Breed competition, or some other non-regular class.

BRACE CLASS: Two dogs that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. The dogs comprising a Brace **MUST** be named at the time of entry. If both dogs are entered in another class at the show, entry fee for Brace Class as a UNIT is \$29.00. In making entries for "Brace Class Only" full particulars **MUST** be given for each dog on individual entry forms. An entry form for a dog entered in a Regular Class or for "Best of Breed Competition" and entered as part of a Brace **MUST** be marked accordingly in the space provided for Additional Classes. "Brace Class." If more than one Brace is entered by same owner, dogs comprising EACH BRACE must be so designated – "Brace No. 1," "Brace No. 2," etc.

NOTE: As the judge's decision in the Stud Dog, Brood Bitch and Brace Classes is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.

CLUSTER OBEDIENCE TRIAL & RALLY TRIAL

ALL OBEDIENCE & RALLY CLASSES WILL BE HELD INDOORS

With the approval of the American Kennel Club, Obedience and Rally Trial classes at the OKC cluster will be consolidated to provide maximum efficiency in scheduling and judging. The Judging Program will include a complete list of breeds to be judged, and the order in which they will be judged. All Specialties in this Cluster that are offering Obedience Classes will be judged together. Each dog will be judged and individual scores recorded in the respective breed's judge's book. For the group exercises in Obedience, all breeds will be judged in one group. If there are more dogs competing than can be spaced four (4) feet per dog on one side of a ring, some must be judged in another group. The judge will divide the class into equal sections and the group exercise will be judged after each section. Following completion of group exercises, the judge will complete the judge's books for all dogs entered in each Obedience class in the respective breed's judge's book. Ribbons and awards will then be awarded by breed. Qualifying points in Obedience are based on the number of dogs in each breed only. All Specialties in this Cluster that are offering Rally Classes will be judged together. Each dog will be judged and individual scores recorded in the respective breed's judge's book. The judge will complete the judge's books for all dogs entered in each Rally class in the respective breed's judge's book. Ribbons and awards will then be awarded by breed.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be consistent with the eligibility dates for the AKC Eukanuba National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form. **SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S):** There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show.

- There will be NO loading or unloading of crates/dogs at ring side during show hours! Loading and unloading will be at the Livestock Barn and Horse Barn ONLY – gates open at 6:00AM. Day grooming will be available in the Horse Barn and Reserved Grooming will be in the Livestock Barn. Gates will close no earlier than 10:00PM each night. Grounds and grooming barns will be available Wednesday at 2:00PM.
- **No vehicles will be allowed on the show grounds after 7:00am on Friday unless they have reserved parking.**
- There will be NO day parking on the fairgrounds.
- Overnight parking will be handled by J.I.F.Y.S. Day parking is \$5 per day.
- Power Outlets – Use of ALL power outlets is at user’s own risk.
- No practicing allowed in rings at any time.
- No dogs to be left overnight in grooming building.
