– NOTICE TO EXHIBITORS –

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- The AKC will collect a \$1.50 AKC Event Service Fee and a 50 cent Recording Fee for the first entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for the AKC. If a dog is entered in more than one class in the show, the Event/Recording Fees to be collected on the first entry only. (AKC Rule. Chapter 11, Section 2). Rally Regulations, Chapter 1, Section 3. Recording Fees. At every licensed or member club rally trial, a recording fee of \$3.00 shall be required for each entry of each dog.
- **CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS**
- The judging will start promptly. Dogs may arrive anytime prior to their time of judging, and may leave immediately thereafter, unless required for further judging.
- Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and/or its Superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. **RESPONSIBILITY FOR COMPLETENESS OF ANY ENTRY RESTS SOLELY WITH ENTRANT.**
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund of entry fee for bitches in season. There is no refund for **DUPLICATE ENTRIES or OVERPAYMENTS.** The Superintendent will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show **NO REFUND** will be made.
- **RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE.** The Superintendent will add a \$20.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may result in their being put on a **CASH ONLY BASIS.**
- **REFUNDS** for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent **AFTER THE SHOW.** An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- **JUNIOR SHOWMANSHIP SUBSTITUTION OF DOG.** There will be an Administrative Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show.
- Only dogs eligible for this show will be admitted into the show area. There is no provision for unentered dogs.
- **ENTRIES WILL BE ACKNOWLEDGED** after entries close with entry acknowledgment and judging program to address on entry. Should Exhibitor NOT receive an acknowledgment within a reasonable time, PLEASE notify the Superintendent at (360) 683-1507 or email dogshows@dbamlg.com.

OPEN CLASS: For Boys and Girls who, at the time entries close, have won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show. **OPEN CLASS DIVIDED:** **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Jr. Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 816-3776.

NOTICE TO EXHIBITORS REGARDING CORRECTIONS OR CHANGES TO ENTRIES: Corrections other than the specific changes listed in Ch. 11, Sec. 6 (i.e. sex of a dog, transfers between age specific classes, and “move-up’s” to BOB or BOV) are the only changes to the entries superintendents or secretaries are authorized to make after closing of entries. Owners are responsible for errors in the entry forms, regardless of who may make such errors. **THIS RULE IS BEING STRICTLY ENFORCED BY THE AMERICAN KENNEL CLUB.
