## **PLAN OC OBEDIENCE MATCH (Ring Rentals)**

To be held in the same rings used for  
Rally & Obedience during the FVKC trials.

**SUNDAY Afternoon, June 21, 2015**

**One Hour after end of Obedience Trial until 7:30 pm**

**\$5.00 for five minutes of individual ring time.**

**Group stays (at no additional charge) after approximately every 10 dogs.**

We will have two rings in use at the same time, each with a timer. Labor to set up the rings will have to come from the exhibitors themselves. You must provide your own "judge" if you want one.

Sign-up sheets will be available Sunday at noon near the obedience & rally rings. You can sign up immediately prior to the match, if there is time available. Time will be reserved on a FIRST COME, FIRST SERVED BASIS. You may not use consecutive time slots. For example, if you want 15 minutes, you must sign up in five-minute increments, allowing someone else to have a turn before you repeat. WE QUIT AT 7:30 PM SHARP.

You pay no fee until you are ready to have the ring set up (jumps, no jumps, correct heights, etc.). Your five minutes begin when you and your dog walk into the ring. You may use your five minutes to do run-throughs, exercises or parts of exercises, play, train or stays. Any regular or non-regular classes can be run-through. Verbal praise, corrections and gentle guiding are allowed (Harsh corrections are not allowed). Food, toys & training aids are allowed, but you must pick up any food dropped on the mats. You may work with a helper.

# National Owner-Handled Series

SUNDAY • MONDAY • TUESDAY

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

**DON'T FORGET TO CHECK THE OWNER-HANDLED BOX ON THE ENTRY FORM IF ENTERING THIS COMPETITION.**

All dogs that are owner-handled and are not solely owned or exhibited by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form.

Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and assistants to current professional handlers may not exhibit the dog in any breed competition during the entire show.

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog within the last five years.*

## NATIONAL OWNER-HANDLED SERIES GROUP AND BEST IN SHOW JUDGES

Group and Best in Show Judges for NOHS

will be the same as their respective Regular Judges all three days.



## JUNIOR SHOWMANSHIP COMPETITION

**NOVICE CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

**MASTER CLASS:** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be consistent with the eligibility dates for the AKC Eukanuba National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

**NOVICE AND OPEN CLASS DIVIDED:** Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form. **NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.**

## **BEGINNER PUPPIES (4-6 MONTHS OF AGE)**

### **AKC Sanctioned Beginner Puppy Competition – Sunday, June 21**

---

**Entries will close Wednesday Noon, June 3, 2015 at Superintendent's office.**

#### **Section 1- Classifications**

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23.

The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

#### **Section 2 – Entry and Eligibility**

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
  - Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay. Dogs may not be exhibited by current assistants and household members of a professional handler.
- Entry Fee: \$21.00 (including AKC recording fee of \$2.00 for each dog. These fees are paid to the American Kennel Club.)

### **USE OF RAMPS – ALL BREEDS**

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required. The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Clumber Spaniels, English Springer Spaniels, Field Spaniels, Sussex Spaniels, Welsh Springer Spaniels, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Chinese Shar-Pei, Keeshonden, Norwegian Buhunds, Polish Lowland Sheepdogs, and Norrbottenspets (Misc.).

At the discretion of the judge, the following breed may be judged on the table or on a ramp through all levels of competition including Group and Best in Show judging: Cardigan Welsh Corgis.

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels and Whippets.

The following breeds must be judged on a ramp through all levels of conformation competition: Basset Hounds, Bulldogs, and Chow Chows. This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions. Ramps can be used in emergency situation to judge any breed.

In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds. (01/2015)





- The American Kennel Club will collect: a \$3.00 Event Service Fee and \$.50 Recording Fee where applicable for the first entry of a dog, plus a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single-entry classes, in all AKC licensed and member club events. At every licensed or member club rally trial, a recording fee of \$3.50 is required for the first entry of each dog and a recording fee of \$3.00 is required for each additional entry of the same dog. The event-giving club shall assume the responsibility of collecting all Event Service Fees for The American Kennel Club. These event service and recording fees shall be forwarded to The American Kennel Club along with all other required event results within seven (7) days of the close of the event.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE.
