Points Available for Reserve

The Schipperke Club of America will award at its National Specialty a three point major to Reserve Winners Dog if the Regular Class Dog entry is twice the required number for a five point major in the division where the National Specialty is held.

The Schipperke Club of America will award at its National Specialty a three point major to Reserve Winners Bitch if the Regular Class Bitch entry is twice the required number for a five point major in the division where the National Specialty is held.

CLASSIFICATION

No dog shall be exhibited in a licensed or member dog show, unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. (Rules Applying to Dog Shows, Ch. 11, Sec. 1)

Spayed and neutered animals may be entered and shown in Veteran Classes at specialty shows. Winners of the Veterans Classes may also compete for Best of Breed, provided they are undefeated in any Regular Class at this show.

Non-Regular Classes (Involving Multiple Dog Entries)

NOTE: *As the judge's decision in the Stud Dog, Brood Bitch, Brace Class is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class.*

AWARD OF MERIT: The Regular Class Judge, may, at his/her discretion, present an Award of Merit Rosette to no more than five (5) Dogs and/or Bitches who have competed in the Best of Breed judging at this Specialty. Best of Breed and Best of Opposite Sex are not considered for Award of Merit.

STUD DOG CLASS – For Stud Dogs and two (2) of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of Stud Dog need not necessarily be owner of Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered individually in one of the Regular Classes or Veterans Classes, (provided the Get has not been spayed or neutered), or Best of Breed Competition. See NOTE below.

BROOD BITCH CLASS – For Brood Bitches and two (2) of their Produce. Brood Bitches must be entered in the Brood Bitch Class and must be shown in the ring with their Produce. Owner of Brood Bitch need not necessarily be owner of Produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Produce must be entered individually in one of the Regular Classes or Veterans Classes, (provided the Produce has not been spayed or neutered), or Best of Breed Competition.

NOTE: *Chapter 11, Section 8 of the Dog Show Rules provides that a "castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."*

BRACE CLASS – A brace is defined as two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. The dogs comprising a Brace MUST be named at the time of entry. If more than one Brace is entered by the same owner, the dogs comprising EACH Brace must be so designated "Brace 1"; "Brace 2", etc. Please submit Brace entries together.

SWEEPSTAKES & VETERAN SWEEPSTAKES

SWEEPSTAKES

The Sweepstakes is open to all Schipperkes who are at least 6 months of age and under 18 months of age at the time of the Specialty. All dogs entered in a Sweepstakes class must also be entered in a Regular Class or for Best of Breed Competition at this Specialty, at the regular entry fee.

VETERAN SWEEPSTAKES

The Veteran Sweepstakes is open to all Schipperkes who are at least 8 years of age at the time of the Specialty. All dogs entered in a Veteran Sweepstakes class need not be entered in another class at this Specialty. *Spayed and neutered animals may be entered and shown in Veteran Sweepstakes.*

The purpose of the Futurity is to encourage the breeding of the best possible Schipperkes and to reward the breeders for their efforts. Prize monies are therefore divided between the owners and the breeders. Detailed entry instructions are provided on the SCA website, in the SCA Bulletin or may be obtained by contacting the SCA Futurity Chair.

FUTURITY STAKE

The 2016 Futurity stake is for any properly nominated and entered Schipperke that is at least six months old on the date of the Futurity competition and that has not been eligible for any previous Futurity Stakes. All dogs entered in a Futurity class must also be entered in a Regular Class or for Best of Breed Competition at this Specialty, at the regular entry fee.

Futurity Classification

Dogs, 6 months and under 9	Bitches, 6 months and under 9
Dogs, 9 months and under 12	Bitches, 9 months and under 12
Dogs, 12 months and older	Bitches, 12 months and older

Class winners will compete for Best in Futurity and Best of Opposite Sex to Best in Futurity.

MATURITY STAKE

The Maturity is designed to be educational and a complement to the Futurity. By bringing back the previous Futurity nominees and showcasing them as adults, breeders will have the opportunity to see not only how individual dogs have developed, but also how particular bloodlines grow and mature. The Maturity is for adult dogs that came from nominated litters. They need not have been shown in the Futurity, but must have been part of a Futurity nominated litter. They may be shown in Maturities until 8 years of age. Owners of eligible dogs will have the right to enter those dogs. The ages of the dogs will range from those that were Futurity eligible the immediately preceding National Specialty up to eight years of age. Maturity Dogs need not be entered in the regular classes. In addition, to fully evaluate bloodlines, we will also accept spayed and neutered dogs.

SCHIPPERKE CLUB OF AMERICA

Maturity Challenge Classes – Classes Divided by Sex

The six class winners will compete for Best in Maturity and Best Opposite Sex to Best in Maturity.

Best in Maturity winners will not be eligible to compete in future Maturity events.

Maturity Class 1 - Open to dogs and bitches that were Futurity eligible the immediately preceding National Specialty and under four years old on the date of the event.

Maturity Class 2 - Open to dogs and bitches that are four years old and under six years old on the date of the event.

Maturity Class 3 - Open to dogs and bitches that are six years old and under eight years old on the date of the event.

Division of Futurity/Maturity Entry Money

Club shall retain 35% for expenses.

After deductions, the balance of the monies received will be divided as follows:

Best in Futurity/Maturity.....	15%	Best of Opposite Sex.....	5%

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. JUNIOR SHOWMANSHIP COMPETITION – BOTH SPECIALTIES

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC Eukanuba National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.
